Discussion on Water Quality Management Amendment

The Mayor requested that Borough Engineer Bob Guerin step up to present an explanation of the proposed amendment and let the council know what has changed. Mr. Guerin explained that the DEP is requiring both Sussex and Morris Counties to participate, as both have part of the Watershed area within their jurisdiction. Mr. Guerin referred to a map while explaining the area concerned. Mr. Guerin asked guestions related to the service sewer area.

BOROUGH ADMINISTRATOR REPORT

This report was submitted Wednesday, January 2, 2013. The Mayor asked if there were any questions. No questions or comments were made.

COMMITTEE REPORTS

Finance & Insurance: E. Still J. Sylvester

Councilman Sylvester reported the following:

In the month of **December**, the total income the Boro received was \$110,182.27 as compared to the previous year of \$199,749.20

Year to Date:

Miscellaneous Revenue Not Anticipated (MRNA) \$29,927.07 in 2012 vs. \$45,164.43 in 2011 *A decrease of \$15,.237.36 over 2011.*

Other Licenses. including Clerk's Fees:

\$126,711.66 in 2012 vs. \$10,671.66 in 2011.

An increase of \$19,040.00

State Aid

\$436,063.00 received in 2012 vs. \$437,083.00 in 2011. *A decrease of \$1,020.00*

Grants in Aid

\$51,999.53 in 2012 vs. \$27,344.23 in 2011

Taxes Collected

\$7,563,011.68 collected in 2012 vs. \$7,701,182.94 in 2011 *A decrease of \$138,171.26 from last year.*

Income Total Year To Date:

\$8,207,712.94 in 2012 vs. \$8,318.446.26 in 2011.

A decrease to date of \$110,733.32

The Mayor noted that the first full look at the budget would be on the 16th.

Economic Development: R. Hathaway E. Still

Councilman Hathaway stated that they are still waiting to hear from Quick Chek regarding the permits. The Pocket Book Factory (2 Flanders Rd.) has a short term lease for storage. Plans are expected to be brought to the Planning Board in February. The NCP stakeholders meeting will be this month.

Public Safety: J. Sylvester E. Koster (Police, Fire, Rescue)

The Fire Department in December noted 54 firefighters volunteering 400.5 hours to the residents of the Borough of Netcong. There were 4 general alarms, 4 drills and 3 meetings. 6215 total man hours were volunteered for the year.

For the month of December, the Stanhope-Netcong Ambulance Squad responded to a total of 47 calls, one of which was out of town. They treated a total of 34 patients and made 28 trips to area hospitals. They travelled 699 miles and volunteered 137 hours and 13 minutes. There were no assists by the Stanhope Fire Department.

For the year of 2012:

There were 676 calls answered, 21 were out of town. A total of 504 patients were treated and there were 410 total trips to area hospitals. They travelled 10566 miles and volunteered 2528 hours and 45 minutes. There were 7 assist from the Stanhope Fire Department, 2 assists from the Netcong Fire Department and 1 assist from the Netcong Police.

The Police Department in December answered 313 calls. There were 106 motor vehicle summonses written. There were 21 local ordinance summonses written. We are back to full staff. The Chief wanted the Council to know that the new traffic pattern will begin through the circle area on Saturday. The police have also been making two walkthroughs through all the school systems.

Dept. of Public Works & Utilities:

E. Koster R. Hathaway

Water Department: Replaced a 3/4" service line that was leaking in the street and sidewalk areas at 103 Main St. Turned the water service back on at 2 Flanders Rd. as requested (Pocketbook Factory)

Sewer Department: Unclogged a blocked sewer lateral at 13 Maple Ave. on the street side

Buildings & Grounds: Shoveled snow from all borough sidewalks as needed **Recycling:** Collected 11 loads of leaves and 14 loads of brush from the residents in December, also chipped (what would have been) approximately 50 loads of brush throughout the town

Snow and Ice Control: Plowed and salted roads as needed. DPW employees worked 75 hours overtime in December during snow emergencies. Used 126 ton of salt for snow and ice control in December

Other: Brought all light towers and message boards that were used at the holiday parade back to the county. Assembled 15 of the generators that we received from JCP&L and distributed them to (2 to each fire dept., 2 to each school, 2 to the ambulance squad, 4 to DPW (1 for each well house and 1 for the DPW garage) and 1 to the police dept., the remaining 35 generators are being

stored at the borough garage until direction is given. Delivered senior meals during Wendy's vacation. Helped at the school with removing a damaged play gym.
