MINUTES OF THE MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF NETCONG HELD OCTOBER 8, 2015 AT THE NETCONG MUNICIPAL BUILDING, 23 MAPLE AVENUE, NETCONG, NEW JERSEY COMMENCING AT 7:30 P.M.

Mayor Nametko called the meeting to order at 7:26 P.M.

PLEDGE OF ALLEGIANCE

STATEMENT OF OPEN PUBLIC MEETINGS ACT

The Borough Clerk read the following statement:

ROLL CALL

Those in attendance were Councilwoman Butler, Councilman Hathaway, Councilman Koster, Councilman Laureys, Councilman Still, Councilman Sylvester and Mayor Nametko. Also present were Mr. Blakeslee, Borough Administrator and Mrs. Eckert, Borough Clerk.

APPROVAL OF MINUTES

No minutes were presented at this meeting.

Netcong Elementary School Superintendent Dr. Gina Cinotti to Address Mayor and Council

Dr. Cinotti gave an introduction and explained her family history in Netcong. She wishes to bring back and retain all those traditions. She stated that she had visited many different schools in the area and proclaimed that Netcong School is very unique. There are many traditions but there are some academics that could be improved. Dr. Cinotti did not feel that there were as many honor students as there should be. Algebra and Spanish placement scores are not what they should be. 31% of students were rated average or below average. She felt this was not acceptable. To get back on track is a process. They had to cut two full time teachers which translated to bigger class sizes. The schools need funds to run, however 75% of the budget goes to salaries. She presented a screen with

comparable districts – Netcong is spending less which has impacted the level of education. The spending in similar districts is much higher than Netcong. The school administration is asking for \$200,000.00 beyond the regular 2% increase. This amounts to \$176.00 a year more per household. They are asking for 'yes' vote on November 3rd to get them back on track.

Mayor Nametco asked that if there were small class sizes, why are the test scores so low. Dr. Cinotti explained they are starting a new process of changing the education program every few years to match the standardized testing.

Dr. Cinotti thanked the Mayor and Council for their time. She hoped that they would come to the school and ask her questions. Dr. Cinotti also offered that the Council could contact her at home any time.

PUBLIC PORTION OF MEETING

Bernadette Dalesandro – 32 Barone St.:
 She began by stating that when things go wrong news piles up. She came to this meeting to provide good news. At the last Board of Education meeting, the Board gave a complementary resolution to the Police Department. Today she would like to present Chief Jim Blesson a certificate of appreciation for all that the he does for the school and town. She asked everyone to thank the Police Chief for the great job he does.

A Motion to Close the Meeting to the Public was made by Councilman Sylvester and seconded by Councilman Hathaway.

Mr. Blakeslee stated that the Council needs to keep close eye on this since it is near our wells. Councilman Hathaway requested that the state is notified of the progress on this application.

Councilman Still noted that other areas may not be aware of what is in the surrounding area. Councilman Hathaway suggested that a letter be sent to Roxbury so the Council is kept abreast of this application.

3. Jay Reilly – Resignation Letter

A motion was made by Councilman Sylvester and seconded by Councilwoman Butler to accept the resignation with regret.

4. Letter from St. Michael School - Thank you to Police Department

The Mayor explained that because the Church St. road project was not completed before the beginning of the school year, the Chief and Police Department spent time to prepare traffic routes and control to keep from having issues. Everything ran very smoothly during this time. He wanted the police team to know that the Council appreciates all that the police do.

The Chief of Police thanked the men who work for him.

BOROUGH ADMINISTRATOR REPORT

Mr. Blakeslee brought up the issue regarding changing the recycling day to Thursdays instead of Mondays. He requested feedback for this possible change. Councilman Hathaway replied that he would rather get rid of bottles on Monday in light of the amount of alcoholic beverages that are consumed during the weekend. The Mayor noted that there are more holidays on Mondays. Councilman Laureys asked if grass pickup could be changed. Mr. Blakeslee summarized that he would leave the cycling day on Mondays based on this conversation.

Councilman Hathaway noted that the big news for this month was that there was an agreement with New Jersey Transit and the Mayor signed the excise letter. The RFP can now be sent for developers for the transit property. He noted that the town could get traction on developing transit properties in 2016.

Crown Point: They are in the process of completing phase one on the Quirk property. Councilman Hathaway did not feel that anything unexpected was occurring. He noticed that the Quirks are strongly protecting their interest.

Pocketbook Factory: The demolition permit was received and Mr. Blakeslee spoke with Byram Construction Official, Dick O'Connor to start demolition before the end of the year so the town could keep tax benefits.

Councilman Sylvester asked about the sewer allocation. He pointed out the Quirk property allotment. Councilman Hathaway said they provided some numbers. There may be some issues with the water source. There will be a need to expand systems. There is not enough water to supply all that can be developed. They are working on this at the committee level. The sewage system should be fine according to the Borough Engineer. The Mayor mandated that the Council needs to keep a close watch on this since we allotted for the Railroad Ave. project.

(Police, Fire, Rescue)

For the month of September 2015, Councilman Sylvester noted that there were 64 total calls, 61 were in town and three were out of town calls for the Ambulance Corps. There were a total of 23 patients and 23 trips to the hospital.

The Netcong Fire Department had a total of 9 calls. One call was out of town. There were 10 drills, five meetings, and six special details which included the parade, Netcong Day and more. The firemen also attended the NJ SF convention. Total of 59 firefighters provided 1002 hours of volunteer time for Netcong.

The Police Department reported lower numbers for this month due to vacations, holidays, Netcong Day and other anomalies during this month. There were 286 calls for service, 64 traffic details and 22 days of training. Councilman Sylvester elaborated about the job at St. Michael's which he felt was in no way simple.

Councilman Sylvester also noted Jay Reilly's 28 ½ years of service and always being there for the town. He requested some sort of recognition for his service.

PRIVILEGE OF THE FLOOR TO THE COUNCIL

The Council President had nothing to report at this time.

Councilman Koster wished to report that at the Boonton parade they won best overall marching trophy.

Councilman Hathaway reported that Lake Musconetcong is in the process of being drawn down. The harvester is now out of the lake. Swirl chamber remediation will take place soon. The Lake will be dropped two feet and the swirl chamber 3 inches. He was not sure if it will be left down all winter. He thought they might refill early if the shoreline dries out.

MAYOR'S COMMENTS

The Mayor spoke with Marvin briefly about doing a revaluation next year. It is costly but we are at the point renegotiated properties are throwing off the levy. We need to plan for it in 2016.

Mr. Blakeslee noted that typically payment is made by passing a special emergency to pay for cost over a 5 year period.

The Mayor stated that the county will eventually call for a revaluation. The Mayor asked Mr. Blakeslee to reach out to peers for companies to use. It was noted that this will cost around one hundred thousand dollars.

It was noted that the Borough has cameras in our parks and buildings. The Mayor thought there should be cameras at our wells to protect our water sources.

RESOLUTIONS

It was noted that this resolution is replacing the 1983 at Co# 2 used on a regular basis. Councilman Koster noted that this has already been approved.

Councilman Hathaway noted that there was no presentation to the Council. He was not trying to cause a problem but is a very large purchase. Both vehicles will total \$100,000. He is not at all questioning the need for these just the process in obtaining them. Councilman Sylvester provided a description of the vehicles.
