MINUTES OF THE MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF NETCONG HELD MAY 2, 2019 AT THE NETCONG MUNICIPAL BUILDING, 23 MAPLE AVENUE, NETCONG, NEW JERSEY COMMENCING AT 7:30 P.M.

Mayor Nametko called the meeting to order at 7:30 P.M.

PLEDGE OF ALLEGIANCE

STATEMENT OF OPEN PUBLIC MEETINGS ACT

The Borough Clerk read the following statement:

Those in attendance this evening were Councilman Albensi, Councilman Hathaway, Councilman Koster, Councilman Laureys, Councilman Still, Councilman Sylvester and Mayor Nametko. Also present were Mr. Blakeslee, Borough Administrator and Mrs. Eckert, Borough Clerk.

CROWN POINT PRESENTATION

Mr. Jeff Milanaik apologized for not being available for the prior meeting, but had some personal issues to attend to. He provided an update on the Crown Point Redevelopment Project. He explained and gave details on why there have been some delays with the start of this project. Easements needed to be obtained from neighboring properties which caused the delays. There was also an unexpected title search. He gave the details on these issues. He said due to these circumstances they have not been able to close on the property. The new projected closing is the end of May. Once the closing takes place they will begin obtaining the permits to start work. They have added another investor in

this project. There has been work going on but it is the behind the scenes work that is common with these types of projects.

The Mayor asked when the demolition will start. Mr. Milanaik is hoping for right after the closing. He said asbestos would need to be removed before demolition will take place. Mr. Blakeslee requested they notify us when the asbestos removal company will be coming so we can notify the public that this is a safety measure before the demolition. There was further discussion on the details of the beginning of the project. The Council thanked Mr. Milanaik for his time.

He feels there may be instances where we may not want to waive these fees. He requested there be a wording change for this. Councilman Sylvester made a comment about the wording. Councilman Hathaway feels this section needs to be reworded because it is not clear. There was brief discussion among the council on this subject. Mr. Hathaway felt there was also an issue with the wording for a social food truck vendor. The Mayor agrees with Councilman Hathaway on these issues. There was further discussion among the Council on this. Mr. Blakeslee will contact Mr. Bucco to clarify.

There was lengthy discussion regarding the recycling issues and discrepancies. Councilman Sylvester asked when we can notify the public on the changes.

PRIVILEGE OF THE FLOOR TO THE COUNCIL

The Council President asked about insurance for fireman playing softball or any recreational activity on the fields. He provided details regarding this request. Councilman Still had questions about this and requested a copy of the insurance policy and the name of the insurance agency. He is not pleased with the JIF and would like to look into other insurance. There was brief discussion among the Council. Councilman Koster asked if a different insurance cannot be found, can the Borough pay for the insurance so the fire department can play softball. There was heated discussion on this subject. Mr. Blakeslee gave details on the insurance we now carry. There was lengthy discussion on possible solutions to this problem. Councilman Koster will check on a policy from another insurance company.

MAYORS COMMENTS

The contractor will be starting the demolition of the fence at Arbolino Field. It is about a 60-day process to do the project. He gave details on the Arbolino Park project and that we will have to close Arbolino Park for a short period of time while this project is taking

place. The Mayor is working with the Recreation Commission to notify the players when they will not be able to use the field. There was detailed discussion among the Council.
