MINUTES OF THE MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF NETCONG HELD SEPTEMBER 12, 2013 AT THE NETCONG MUNICIPAL BUILDING, 23 MAPLE AVENUE, NETCONG, NEW JERSEY COMMENCING AT 7:30 P.M.

Mayor Nametko presiding.

PLEDGE OF ALLEGIANCE

<u>CALL TO ORDER – STATEMENT OF OPEN PUBLIC MEETINGS ACT:</u>

Mayor Nametko called the meeting to order at 7:30 P.M.

The Borough Clerk read the following statement of compliance with the Open Public Meetings Act:

Adequate notice of this meeting as defined by the Open Public Meetings Act has been provided by:

- 1. Posting a notice of said meeting in the space provided for such announcements at the Netcong Borough Hall on January 4, 2013.
- 2. Publishing a notice in The Daily Record, the official newspaper of the Borough of Netcong on January 9, 2013 and mailing a copy to The Star Ledger on January 4, 2013.

ROLL CALL

Those present at the meeting were Councilman Laureys, Councilman Hathaway, Councilman Sylvester, Councilman Still, Councilwoman Butler and Mayor Nametko. Also present were the Borough Administrator, Ralph Blakeslee, Borough Attorney, Mr. Bucco and the Borough Clerk, Cynthia Eckert.

The Mayor called for a moment of silence in memoriam and honor of those that lost their lives on September 11, 2001.

PUBLIC PORTION OF MEETING

The Mayor opened the meeting to the public and requested that their presentation be 5 minutes or less.

Mr. James Arbolino stepped forward in response to a request at the last meeting to get his recollection of the Veterans Monument. He confirmed that the monument lists all veterans that were born in Netcong. Councilman Hathaway asked how the names were collected. Mr. Arbolino replied that initially the request came through the newspapers. At one point, a letter went out to the entire community. This included any veteran who served their country, whether it

was during wartime or not. The Mayor requested that this information will be memorialized on a document. Mr. Joe DiLorenza was credited with a great deal of work that was done for this project.

Mr. Charles Cedro, 6 Allen St., Netcong requested his monthly update for Mr. Bucco. Mr. Bucco reported he had good news. He noted he received no response to his regular mail so he sent the letters certified and got a response from the Department of Transportation. The Assistant Commissioner was away with an injury and would be back next week to respond to letter. Mr. Bucco continued that he got a call from New Jersey Transit who stated that they did receive the certified letter. This representative stated that the DOT was taking responsibility and would correct the matter. Mr. Bucco challenged that comment and the representative stated he would set up a meeting with Ralph and possibly Mr. Olivo from DPW. Mr. Cedro was not terribly pleased with this information. Mr. Olivo stepped up to provide clarification on the pipes that needed action. The Council, Mr. Cedro and Mr. Olivo continued to discuss what pipes needed

Councilman Hathaway asked what an acceptable time frame would be for a situation like this. Mr. Bucco is going to call and get an end date. Councilwoman Butler reminded the Council of an additional issue regarding the roads near these pipes. Mr. Blakeslee will set up a meeting to have New Jersey transit come down and review the situation with Mr. Blakeslee and Mr. Olivo. Mr. Cedro offered to allow a two-week grace period. Mr. Bucco took Mr. Cedro's phone number and will keep in touch with them.

Mr. Wayne Anthony, 24 Dell Ave., wished to congratulate everyone who worked on Netcong Day. He felt the whole day went very well. He recommended that next year they have the Girl Scouts or the Boy Scouts collect the water cups during the race as the cups all blew into his yard.

Finance & Insurance: E. Still J. Sylvester

In the month of **August** the Borough had total income in the amount of \$1,312,502.09 as compared to the previous year of \$1,495,129.98.

2013 Fire Safety Aid received in the amount of \$960.15.

Taxes Collected

Taxes collected in August of 2013 were \$1,121,809.09 as compared to \$1,307,283.76 collect in August of 2012.

Income Total Year to Date:

Total year to date revenues collect is \$6,107,865.82 as opposed to \$5,903,629.29 collected in 2012.

An increase of total income of \$204,236.53

Economic Development: R. Hathaway E. Still

Councilman Hathaway provided the following NCP report for the August 2013 monthly activities:

Media Relations- Automotive feature story to be published in September- will have quotes from Approved Auto & Truck Repair, Motion Auto Body, Netcong Auto Restoration, and Family Ford. Working on a co-op ad for the winter holiday time with Musconetcong News. Media blast for Netcong Day.

Website -Two business spotlights approved: Fulton Bank and Approved Auto & Truck Repair

Facebook Page- We have 406 likes!! We have 118 visits to the Facebook page with 284 page views! People are talking about us is up 13.33%

Operations- Working with Quick Chek on some initiatives, the most recent was Netcong Day. They allowed us to use their parking lot and it was very successful. We have been talking with Family Ford and will be partnering over the next year and continue to reach out to businesses within the downtown to work more collaboratively. The intern is working on the directory.

Councilman Hathaway expressed accolades to all regarding how well Netcong Day was run. He felt the volunteerism provided for this effort was amazing.

He noted that The Pocketbook Factory is moving forward.

Public Safety: J. Sylvester E. Koster (Police, Fire, Rescue)

For the month of August, the ambulance Corps took a total of 71 calls with 2 of them being out of town. They handled a total of 36 patients and took a total of 36 trips. The total miles traveled was 839 in the total hours volunteered was 219 hours and 58 minutes. There were no assists provided by the Police and Fire Departments.

For the month of August, the Netcong fire Department had 8 alarms, 10 drills and 3 meetings. 55 volunteer firefighters provided a total of 628.5 hours of their time.

The Netcong Police Department answered a total of 426 calls. There were 127 motor vehicle summons issued. There were 3 local ordinances summonses issued.

Other: Replaced the ball joints on truck 573---Assisted with Netcong Day as needed---Assisted with the gov deals auction as needed---Replaced brakes and rotors on one police vehicle---Reinstalled the American flags on main St. and Maple Ave for Labor day---Installed emergency lighting on the skid steer
