MINUTES OF THE MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF NETCONG HELD MARCH 13, 2014 AT THE NETCONG MUNICIPAL BUILDING, 23 MAPLE AVENUE, NETCONG, NEW JERSEY COMMENCING AT 7:30 P.M.

Mayor Nametko called the meeting to order at 7:33 P.M.

PLEDGE OF ALLEGIANCE

STATEMENT OF OPEN PUBLIC MEETINGS ACT

Those in attendance were Councilwoman Butler, Councilman Hathaway, Councilman Koster (arrived at 8:03 PM), Councilman Laureys, Councilman Still, Councilman Sylvester and Mayor Nametko. Also present was Mr. Blakeslee, Borough Administrator and Mrs. Eckert, Borough Clerk. Mr. Bucco, Borough Attorney, arrived at 7:35 PM.

APPROVAL OF MINUTES

No minutes were presented at this meeting.

PUBLIC PORTION OF MEETING

Mr. Charles Cedro, 6 Allen St., requested an update regarding the drainage issue.

Mr. Bob Olivo, DPW Superintendent was invited by the Mayor to provide an update. Mr. Olivo started with the report that the culvert was cleaned by NJ Transit this week. He elaborated on the large quantity of all kinds of debris stuck in the pipe. With the pipe clean, the water flow has improved. However the pipe is old and cracked. He feels the pipe will fail again. Mr. Olivo continued that the pipe is the responsibility of NJ Transit. NJ Transit discussed lining the pipe or building a trench. Mr. Olivo recommended lining the pipe. The Council and Mr.

Olivo continued a lengthy discussion on conditions and possible solutions to this ongoing problem.

Mr. Bucco offered to follow up with NJ Transit on the pipe the Council thought should be removed.

A motion to close the meeting to the public was made by Councilman Sylvester and seconded by Councilman Hathaway.

Councilman Sylvester reported that for the month of February, the Ambulance Corps had 50 calls of which 0 were out of town. They treated a total of 29 patients and made 29 trips to the hospital. The miles traveled were 864 miles and the hours volunteered were 233 hours and 53 minutes. There were 3 assists provided by the Stanhope Fire Department.

The Netcong Fire Department had 7 general alarms 3 mutual aid calls out of town. There were 7 meetings and 7 drills. They volunteered a total of 315.3 hours

The Borough Police answered a total of 334 calls. They wrote a total of 116 motor vehicle summonses. There were also 29 local ordinance summonses. They are still one man down.

<u>Water Department:</u> Due to extreme weather conditions in February, an estimated water bill was sent to all customers---Repaired a 6" water main break on railroad Ave and Repaired a 4" water main break on Allen St.---

<u>Comments:</u> NJ Transit cleaned the 36"culvert on Hilts Lane between the manhole on Hilts Lane near the Family Ford gate and the manhole in the park & ride. They were also able to clean the clogged 18"pipe from track area to Hilts Lane. For now, the water is flowing fine but as the video of the pipe proved, the 18" pipe is in very poor condition with breaks and cracks throughout and it will continue to fail until repairs are made--- One DPW Employee remains on workers comp until further notice---
