 Councilman Sylvester inquired about the dead trees from the circle project. Mr. Blakeslee stated that he contacted Mr. Eugene and was notified that they will be replaced sometime this fall. The Mayor asked about the Queen Anne lace (weeds) in that area. The Mayor requested Ralph contact Mr. Eugene again about these issues.

Councilman Koster

• The hedges at the corner of Maple Ave. and Ledgewood Ave. are too high. This poses a safety issue as it is hard to see traffic coming around the curve when you pull out of Maple. Mr. Blakeslee will contact the property owners.

• Public Safety Committee met tonight- there was discussion about staff changes in the DPW due to Mr. Olivo retiring. There will need to be a new hire as well as re-titling for existing employees. The new hire should take place in September to allow time for training before Mr. Olivo leaves in November.

Councilman Still asked if the borough will have enough money in this year's budget to pay a new person. Mr. Blakeslee responded that will they will find the required funding.

The Council discussed the importance of this matter and how to make sure there will be adequate coverage for the duties and responsibilities of the DPW.

Councilman Hathaway

• Is displeased with the timing and quality of actions from the letter regarding the borough's drainage situation. The Council discussed this issue for several minutes. Mr. Blakeslee will contact Mr. Bucco to set up a meeting.

#### **MAYORS COMMENTS**

There have been several situations that have risen since the SID surveys went out last week. There is a discrepancy as to how many "votes" certain owners should receive. Councilman Hathaway explained his understanding of what should be based upon the bylaws.
