MINUTES OF THE MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF NETCONG HELD FEBRUARY 11, 2016 AT THE NETCONG MUNICIPAL BUILDING, 23 MAPLE AVENUE, NETCONG, NEW JERSEY COMMENCING AT 7:30 P.M.

Mayor Nametko called the meeting to order at 7:28 P.M.

PLEDGE OF ALLEGIANCE

APPROVAL OF MINUTES

Minutes were not presented at this meeting.

PUBLIC PORTION OF MEETING

 Ms. Bernadette Dalesandro – 32 Barone St - on behalf of The Netcong Education Foundation came to talk about a fundraiser for the Netcong School, a St. Patrick's Day dinner catered by Burrini's. The cost for food and entertainment will be \$45.00 a ticket. The event will take place on March 5th at The Knights of Columbus. Other fund raisers include a 50/50 raffle. Tickets are \$5 each. Mr. Bucco provided a check for donation.

CORRESPONDENCE

No correspondence was presented at this meeting.

BOROUGH ADMINISTRATOR'S REPORT

Mr. Blakeslee requested feedback regarding the Netcong School Lawn Maintenance situation. Councilman Still asked the DPW Supervisor, Mike Canfield, for his opinion. Mr. Canfield's concern is if they are short of manpower, will they be able to do it. Mr. Blakeslee confirmed that this was a trial for one year with evaluation at the end of the year. Councilman Hathaway suggested a formal agreement for 12 months then a stipend in the future for a shared service. Councilman Koster said he did not have a chance to talk to everyone about it.

Mr. Bucco stated that there should be a shared service agreement in case of accidents, for instance. The agreement should be a written understanding between the two parties. Mr. Blakeslee will get together with Mr. Canfield and Councilman Koster to come up with an agreement, if there is time. The Mayor asked whose equipment will be used. Mr. Bucco said that once all items have been discussed, an agreement can be made.

Progressive Properties was granted subdivision approval to create seven building lots at the end of Railroad Avenue and the Borough entered into a developer's agreement a few years afterwards. The agreement indicated that the Borough would take over the water and sewer utilities installed by the developer. Progressive properties can apply for permits. The Council discussed this and will put it on the agenda for next month.

The Blue Vista project has changed completely. What is now proposed is a Quick Chek with a gas station. The developer would like to work with Netcong for sewer usage. Councilman Laureys asked why the developer cannot hook into a Roxbury Main. Mr. Blakeslee explained that there is no place for them to hook up. Councilman Still added that there are septic systems for houses nearby and no sewer system from other towns by the Shell station site. Councilman Still stated that this is not a problem as they will use our lines and we will make \$4,722.00 annually. He continued that Netcong incurs no costs in this endeavor. The developer will be renting the pipes. It was noted that this will only be for the Shell station property. The current owners are attempting to get some money out of the property by selling to Quick Chek. It was also mentioned that there must be an agreement that there will be no further additions to that line. The developers will be responsible for everything from meter box back. Netcong will only be responsible for what is there now. Mr. Bucco noted that this will be a fee that the Borough can use in the future for repairs that may need to be performed on our lines from their usage.

With regard to the Canadian Geese Project, Mr. Blakeslee wanted to confirm that Netcong wants to continue with this program. The money is in the budget. Councilman Hathaway said it is typically a three year plan. The USDA needs a commitment for funding.

Mr. Bucco inquired about the State grant for demolition of the reservoir and the bat study. He wanted to know if the DEP had been involved and if a decision was made. Mr. Blakeslee replied that there was a discussion with Rutgers University. The wild life biologist was contacted and a discounted study was requested. Mr. Bucco asked if there was anything he should be doing to assist. Mr. Blakeslee responded that when Mr. Bucco speaks with the DEP, it would be helpful if he asks why Rutgers is not on the list of possible organizations that do this work. Mr. Bucco requested documentation regarding this from Mr. Blakeslee.

The two vehicles purchased for the Fire Department should be on the road by the end of this month.

There was a meeting with the Stanhope-Netcong Ambulance Squad earlier in the week about their call system. There was a request made for the Borough to contribute to the cost of equipment.

The Ambulance is 14 years old. It was proposed to keep the body and refurbish it for approximately \$70,000 as opposed to \$140,000 for a new ambulance. He explained that just a gurney costs \$14,000 each. One more officer will go for EMT training. All police department members will be EMT trained.

There was no old business for this meeting.

NEW BUSINESS

1. Lake Musconetcong Regional Planning Board 319 Grant Application

Councilman Hathaway reported that the Chairman of Lake Musconetcong Regional Planning Board, Earl Riley, will be speaking.

Mr. Riley offered that the Grant is for purchase of a hydro rake, which is similar to harvester with a rake attachment instead of bucket. It will take biomass out of lake. This equipment will help to increase volume and health of the lake and river. Weeds will still grow but this equipment will assist in making further progress. Progress over the last 5 years has been good and he would like it to continue. He is looking at another effort to reduce muck in lake by introducing biologic to the lake to eat muck. They have solicited and received support from senators, assemblymen and freeholders from both Sussex and Morris counties. They are requesting support from surrounding towns as well. It was recommended each surrounding town provide an in kind contribution to clean storm drains. There are 6 potential drains. Councilman Hathaway explained where these drains are located.

The Mayor had a question about materials being removed and not causing issues on roads. Mr. Reilly replied that they will let it sit for the better part of a week to dry out in order to avoid a mess on the streets. Councilman Hathaway ran an experiment last year with this process and said the results were pretty remarkable.

Councilman Laureys asked how the bio bacteria affect wildlife. Mr. Reilly said there is no harm to animals or the lake. With last year's experiment, there was a 30% reduction in muck. Mr. Bucco will make changes to the resolution to protect Netcong.

PRIVILEGE OF THE FLOOR TO THE COUNCIL

Councilman Koster stated that he would like to talk to the DPW supervisor about reflectors for fire hydrants. The Mayor added that they would like to mark fire hydrants with the size of pipe so the Fire Department would know whether they can provide enough water. Councilman Koster also explained that the reflectors would make the hydrants easier to locate during snow storms. The Council continued discussion on this matter.

Councilman Hathaway noted that he heard from several people about snow removal from the blizzard. Mr. Canfield and the DPW's performance in Netcong was better than what was done in Bernard's Township. Councilman Hathaway added that it was very efficient and thorough. Mr. Canfield thanked Councilman Hathaway.
