OLD BUSINESS

1. Quick Chek – Roxbury – Redevelopment

Mr. Blakeslee presented an update. If the Council was amenable, the attorney and professionals can come to a meeting to explain the situation.

Quick Chek is planning to put a store and gas station where the Shell station was located. They want to use the Netcong sewer system for this structure. Bob Guerin is working on the details.

Councilman Hathaway asked when the information from Bob Guerin would be available. Mr. Blakeslee said Mr. Guerin has an agreement completed and it can be sent to the Council.

The Mayor wanted to confirm that Roxbury understands that the MSA does not want to take responsibility. Councilman Sylvester commented that really nobody wants this. Councilman Koster said that if they use our meters they have to conform to what we want. Councilman Sylvester said the agreement is just between Netcong and the developer. He added that there is not enough flow for a meter to be accurate.

The Mayor asked if the Council had any questions before the professionals come. The Council maintained that they had no questions but were concerned that they would be able to ensure they would be getting accurate funding for what the town provided. The Council continued discussion regarding the type and amount of waste anticipated. Potential open items for this agreement were discussed.

Mr. Blakeslee will distribute the agreement to the Council and move forward. The Council specified what components Netcong had control of and what aspects Roxbury will be performing.

NEW BUSINESS

1. Department of Transportation – Safe Roads to School Request for Applications

Mayor Nametko asked for this issue to be put on the agenda. He noticed that there is a dangerous situation at the crossing on Route 183. He thought maybe a flashing light could be installed to slow the traffic.

Councilman Hathaway mentioned another area on Allen Street. There is a crosswalk with no curb cuts and parking right at the crosswalk. He noticed the children are not seen when stepping out to cross the street. He mentioned he has almost been struck several times there. Councilman Hathaway suggested the corner at Prospect Street would be a better place because the curb is already cut out there and there is also a streetlight for safety. Councilman Hathaway provided a photo to show credence to his request.

The Mayor agreed that there should be a change. He was originally against the lights on Main Street but recognize that the flashing lights do work. The Council discussed the resistance of the state to support this. Mr. Blakeslee stated that the County does not perform any work on crosswalks.

Councilman Sylvester said the end of Water Street would work as well. Councilman Hathaway said the existing crossing is very dangerous at night.

Mr. Blakeslee will review this with the engineer, police chief and DPW Superintendent. The Council added that we don't need a grant to move this crosswalk. Mayor Nametko said Mr. Guerin should push back with the state for flashing lights.

PRIVILEGE OF THE FLOOR TO THE COUNCIL

Councilman Koster noted that Fire Chief Rob Schellhamer thanked the Council for support on the death of his father.

Councilman Koster also mentioned the need for summer help for the DPW. The Council needs to get this started now. There may be some available help that worked last year.

Councilman Still said it looks like Quirk is moving a lot of items out on the curb with a sign that says "free" and also bringing items to the recycling center.

MAYORS COMMENTS

The Mayor wanted to comment on the safety situation at the reservoir. The Mayor noted that correction would cost approximately \$300,000. He offered that maybe a 2nd fence around the existing one could be installed for \$30,000-

\$50,000. Councilman Sylvester wanted to know where this edict was coming from. The Council continued discussion regarding the reservoir and the fence.

Councilman Koster asked about reservoir recharging. He mentioned that it was a cistern and does not recharge. The Council discussed this.

Councilman Hathaway questioned the \$300,000 figure to fill in the reservoir. He was wondering if an RFP could be sent out for estimates.

Councilman Koster suggested capping it using Netcong resources.

Mr. Blakeslee noted that the \$300,000 figure was a budget amount through DEP.

Mr. Blakeslee will obtain a more detailed accounting of the budgeted amount.
