MINUTES OF THE MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF NETCONG HELD JUNE 9, 2016 AT THE NETCONG MUNICIPAL BUILDING, 23 MAPLE AVENUE, NETCONG, NEW JERSEY COMMENCING AT 7:30 P.M.

Mayor Nametko called the meeting to order at 7:25 P.M.

PLEDGE OF ALLEGIANCE

STATEMENT OF OPEN PUBLIC MEETINGS ACT

The Borough Clerk read the following statement:

ROLL CALL

Those in attendance were Councilwoman Butler, Councilman Hathaway, Councilman Koster, Councilman Laureys, Councilman Still, Councilman Sylvester, and Mayor Nametko. Also present were Mr. Blakeslee, Borough Administrator and Mrs. Eckert, Borough Clerk and Attorney, Robert Oostdyk,

APPROVAL OF MINUTES

No minutes were presented at this meeting.

PUBLIC PORTION OF MEETING

Mr. Grobe, Springfield VA: His wife owns the 26 Hilts Lane property. He spoke with Mr. Blakeslee last month about the bad state of repair of Hilts Lane and the amount of traffic using the street to access Britton St. and Family Ford. He was told the Borough could not provide the same services it provides to the public streets because the street is privately owned. He sent a letter that the Mayor and Council has in its possession this evening. He feels the street is public even though it may have been private years ago. He provided examples such as the Board Approved access to Family Ford and a new home in the back of Hilts Lane that uses this street every day. In addition, the public parks on Hilts Lane and blocks access. This can cause problems for renters with children at 26 Hilts Lane. There are also drainage issues when it rains. It comes down the railroad

area, Hilts Lane, and Family Ford. He feels there should be a curb and drainage system put in to rectify this situation.

The Mayor corrected Mr. Grobes statement and noted that the Borough never gave Family Ford access to their property from Hilts Lane. He then referred to the 1998 ordinance describing the issue of private roads and what the Borough did do even though it was not required.

Mr. Grobe continued to maintain that the road is no longer private. There were cars from the Olivo's, an oil truck, UPS truck, another guest of the Olivo's. In 2007 when the Olivo's home was being considered, Mr. Grobe came to the meeting and opposed the building of this home.

Councilman Laureys suggested putting a sign up to note that this is a private road. Mr. Grobe jokingly stated that he could put a tree across the road.

Mr. Oostdyk attempted to define the difference between a public and private road. He explained that anyone who lives on that private road has the right to allow guests and services to use those roads. We have records of our public streets and the county streets. He says this road is not considered a public street at this time. By ordinance we can allow Hilts Lane to become a public street. As the government we cannot just come in and take the road. The owners must agree to give the property to the town. The road would then need to be brought up to public road standards. The government can also do special assessments to the homeowners to improve the road.

A question was asked as to whether the Methodist Church owns the property that the road sits on. Mr. Blakeslee responded that at some point when the ordinance was made there must have been title work processed regarding this.

Councilman Hathaway suggests this will not be an easy process. Owners would need to agree to this and have their deeds amended to accomplish this. He asks Mr. Grobe what his major concern was regarding the road; the condition of the road or the traffic access. Mr. Grove replied "Both, plus conditions of the road bring safety issues."

Mr Oostdyk says people have the right to build if they meet all the land use standards.

Councilman Still says we need to find out who owns the property. Councilman Hathaway suggested if safety is the concern it could be that the Family Ford traffic is causing those issues. He suggests a letter be written to Family Ford instructing that they should not be using the street. He assumed the Post Office and the homes on Britton Street have legal access to Hilts Lane.

Councilman Still suggested constructing something to block the access. Chief Blesson says he can address the gate issue with Family Ford tomorrow.

The Mayor suggested that NJ Transit is contacted regarding the water issues since it is noted that water comes down from the tracks.

Mr. Blakeslee suggested the ordinance leaves room for maintenance and repairs just not to the standard of a public road.

Councilman Still explained that making the road public would require deeds to be changed at the cost of the homeowners who live on the private road.

The Mayor explained some of the flooding issues have been addressed but there are still some issues to be resolved.

Councilman Hathaway said we can help to solve the access issues and maintenance, but improvements will not be paid for by the residents of Netcong. We cannot use public money to improve private roads.

Councilman Sylvester said last week we were going to look at the ownership of these private roads- Mr. Blakeslee stated the process has been started. Councilman Hathaway said the Borough would also contact the attorney regarding how this can be handled. Councilman Sylvester claimed the wheels have started turning on this issue. It might be possible to put millings on some of these streets. Because the roads are being used by the community it allows the Borough to do general maintenance on these roads. Councilman Sylvester continued that the Borough could do small patches to make the road safe to travel on. Councilman Sylvester says for future reference there must be some record at the County to look up the ownership of these properties. Mr. Oostdyk replied that if it is not a lot it is not taxed. Councilman Still said this issue was reviewed in 1998 which is why the ordinance was written. He assumed that Mr. Bucco has this information in his office.

There were no additional comments from the audience.

A Motion to Close the Meeting to the Public was made by Councilman Sylvester and seconded by Councilman Hathaway.

OLD BUSINESS

1. Antenna Ordinance

The Planning Board addressed the two antennas on the front lawn at a house on Carolyn Way. The intent was to eliminate any more of these dishes located in someone's front yard. The Mayor asked if the Council would like to change the ordinance.

Councilman Hathaway said he understands this discussion come up due to the Family Ford putting a tower on their building. Councilman Hathaway continued that the Council should set some parameters for these towers. Mr. Oostdyk noted that towers were not included in this ordinance. Councilman Hathaway said this is just to set some parameters for this issue. Mr. Bucco stated previously that there is nothing in the current ordinance to not allow these dishes in the front yards. Mr Laureys said we have building codes and wouldn't these issues be covered under these laws. The reply to him was that this is not included. Councilman Sylvester noted that the Council has rules for residential lots for air conditioners etc. At the minimum they should abide with the setbacks. Mr. Oostdyk stated that if you want to consider them accessary items that would be the best way to go with it. The Mayor replied that we want to cover dishes on front yards. Accessary items would include air conditioner units, oil tanks, dishes etc. In general, accessory items cannot be in the front yard. They would have to go to the planning board to get approval. Councilman Still noted this issue began because the dishes were put on someone else's property. It was discussed that unused old items should be removed and should be included in this regulation.

Councilman Still requested height limitations be provided for these items. Cell towers and the like should be regulated. Councilman Laureys was concerned about regulating residents regarding satellite dish heights.

NEW BUSINESS

There was no new business presented.

PRIVILEGE OF THE FLOOR TO THE COUNCIL 8:2053

Councilman Still asked for Mr. Blakeslee to have permission to update the website and keep the dates current. We need to make sure we have everything up to date. We need links as well. Mr. Blakeslee noted that the date issues were taken care of immediately.

Councilman Hathaway noted that this weekend is Stanhope Day. It used to be Save the Lake Day. There will be a fishing contest. Councilman Hathaway visited the Community Association and reminded all that they have access to the equipment to take care of the shore line. Councilman Hathaway continued to note that the lake was treated with herbicide today. The lake issues should be under control within three years with these treatments. Two harvesters are in operation almost every day. Harvesting will be done in front of DiRenzo Park before the concerts begin. The chemical used this year is non-migratory and not near any shoreline. Microbes to eat the muck also went in today along with a lot of testing and monitoring. There significant results with the testing done last year. The monitoring last year was limited.
