MINUTES OF THE MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF NETCONG HELD SEPTEMBER 8, 2016 AT THE NETCONG MUNICIPAL BUILDING, 23 MAPLE AVENUE, NETCONG, NEW JERSEY COMMENCING AT 7:30 P.M.

Mayor Nametko called the meeting to order at 7:30 P.M.

### PLEDGE OF ALLEGIANCE

### STATEMENT OF OPEN PUBLIC MEETINGS ACT

The Borough Clerk read the following statement:

## **ROLL CALL**

Those in attendance were Councilwoman Butler, Councilman Hathaway, Councilman Still, Councilman Sylvester, and Mayor Nametko. Also present were Mr. Blakeslee, Borough Administrator and Mrs. Eckert, Borough Clerk.

## APPROVAL OF MINUTES

No minutes were presented for approval.

# PUBLIC PORTION OF MEETING

Ms. Gina Cinotti, 41 College Rd. is the Superintendent of Netcong School. She noted that the Public Works Committee was contacted about the need for sheds they would like to install since the annex building is not able to be used at this time. The school would like to know if the DPW can move some soil to make room for two sheds. They would also need stone to be laid.

Councilman Hathaway deferred to Mike Canfield (DPW Superintendent). Mr. Canfield said they may be able to do it as long as it does not interfere with the daily working of the DPW. Councilman Hathaway wanted to be sure that the DPW will not be put under any time constraints.

Mr. Bucco (Borough Attorney) asked what work will be done and why the borough will be doing it. Mrs. Cinotti explained that they need to install sheds because the annex is unable to be used.

Mr. David Castanzo, President of Netcong BOE stepped up to the microphone to explain that some of the annex was a garage which was used to house maintenance equipment. The insurance company will not allow the annex to be used due to roof issues. He explained they did have a title search done before the work will begin.

Mike Canfield explained that dirt needs to be moved and possibly hauled out to provide a flat surface for the sheds. Mrs. Cinotti noted that they have obtained construction permits for this project and set backs were determined. The Mayor noted that current pervious coverage would become impervious.

Mr. Bucco offered his concerns about water runoff and possible lawsuits for both the school and borough. He suggested a shared service agreement would be the best way to provide protection to the borough as long the wording in the agreement shows the borough will not be held responsible.

A motion for a shared service with the Netcong Board of Education for the grading of soil for the installation of sheds was made by Councilman Hathaway and seconded by Councilman Sylvester.

### **CROWN POINT PRESENTATION**

Mr. Blakeslee provided an explanation/introduction to this presentation.

Mr. Jeff Milanaik from Crown Point introduced himself and explained the particulars about the Quirk property project. They will be purchasing the property and moving forward with a redevelopment plan for this area. Once they have final engineering they will be coming to the planning board with the full plan.

Mr. Tom Fury introduced himself as a member of the Crown Point team.

Mr. Milanaik provides a drawing of the property area. He explains what is currently there. Their plan is to demolish all current building's and replace them with four separate residential buildings. The nice feature is the proximity to Furnace Pond. There are some issues with drainage. They are working with DEP with some issues. They are looking at 126 units which would be one and two bedroom units targeted at millennials. The breakdown was provided: 60% - 1 bedroom (750 s.f.)

40%- two bedrooms (1000 s.f.). The parking recommendation is 1.7 cars per unit based on statistical data. They also want to keep the character and neighborhood feel in this development. Two buildings will be 3 stories. One building will have an elevator and the other will be a walk up. Back buildings will be 4 story buildings. The buildings in the back will not appear tall because of the grade of the property.

Mr. Milanaik provided another drawing of the preliminary elevation concept plan. Some buildings will have garage access. He provided more details about the look of the buildings. The next drawing presented floor plans of the buildings. He provided details of each floor plan and added that there will be COAH housing included. They are very close to completing the contract with the Quirk family.

The Mayor commented that the profile picture with the houses does not present the garage facing the street and the garages will be facing the back. He also noted that a walking path will be included which will eventually go to Waterloo and Hopatcong State Parks.

Councilman Sylvester asked if the buildings have indoor sprinkler systems. They responded that they will be there. Mr. Milanaik explained all that are code required. He plans to be in contact with the Fire Chief to go over all fire fighting issues. Councilman Hathaway pointed out the 60" pipe will eliminate our water problems which we have been struggling with for years.

## BOROUGH ADMINISTRATOR REPORT

Mr. Blakeslee provided an update of the Hillside Ave. water quality: flushing is continued with minimal improvement. Hydro flushing is due on Sept. 26<sup>th</sup>. Mr. Guerin has requested an additional main to be added to the trust fund application to replace the mains in the Hillside Ave. area. Mr. Blakeslee related they can be added very quickly to the Borough's existing water main project. A motion was requested from the Council.

A motion was made by Councilman Still and seconded by Councilman Hathaway to authorize the addition of a 6" water Main from the corner of Allen St. to Kings Rd. for the Trust Fund Application.

### **OLD BUSINESS**

#### 1. Private Roads

Mr. Blakeslee requested input from Mr. Bucco regarding how the Borough can finance these projects.

Mr. Bucco provided two options:

- 1. There is a statute that allows the Borough to adopt an ordinance that allows the Borough to spend public money on these roads without owning or taking title of them. He noted that Netcong already has an ordinance for these streets.
- 2. Adopt an ordinance to own the streets and make them a public road. He explained how this was considered in another town. They adopted an ordinance that stated they accepted those roads as a public street for the width of the pavement or the Council can do the title work to see if there is anything that delineates those areas and the borough becomes responsible. The public funds could be used for this or an assessment can be put on the owners that affront the street. He provided information regarding how these assessments are calculated. The Council must remain cognizant that these paving projects can produce drainage issues. He feels on the smaller roads it is better to go the ordinance route and keep it a private road but perform

some work to improve these roads. Larger roads should probably be deemed public roads. Councilman Still asked if it would have to meet public standards. Mr. Bucco says if it remains private you do not have to meet the standards. Councilman Sylvester asks if they would qualify for grants. Mr. Blakeslee and the Mayor suggested they would not be eligible for grants because they are dead end roads.

Mr. Bucco said the Borough is able to take away services to force the property owners to improve the roads.

Mr. Blakeslee explained that the estimated costs are at least \$250,000.00 without the drainage issues.

Councilman Hathaway offered that maybe tar and stones (chip and seal) may be a better fix for these roads. Councilman Still suggested we look into other low cost solutions.

The Mayor said that once the Borough repairs one street, it will set precedent and all private roads will want this.

Mr. Bucco stated that if the Council's intention is to keep the roads as private roads, a list of the worst to least conditioned roads should be made and the roads should be enhanced over a period of time. It was noted that the Council will inform interested parties and there will be further discussions on this issue.

### 2. Crosswalk on Allen Street

The Mayor noted that Mr. Blakeslee, Councilman Hathaway and the Police Chief were at the sight to survey. A temporary resolution for the crosswalk is a crossing guard put at this sight. Mr. Guerin will look in to moving it which will require contacting the county. The crossing guard offered that it is obvious to him that the crosswalk should be moved.

### **NEW BUSINESS**

1. Social Affair Permit - Knights of Columbus - Comedy Night - October 1, 2016

Councilman Sylvester's request to abstain was discussed briefly.

The topic of the Circle's dead trees was brought forward by Councilman Sylvester. Mr. Blakeslee replied he has called several times and he will call again.

### MAYOR'S COMMENTS

The Mayor brought up the topic of a sunken gas or water cap on Main St. He was concerned for the runners. He also told everyone that he would see them on Netcong Day.
