1. Lake Musconetcong Regional Planning Board - 2016 Annual Report

The Mayor asks if everyone has seen the report. He expressed concern regarding the effort involved. Councilman Hathaway reported that there will be a meeting with Senator Oroho and Mr. Bucco next month. He explained we need help from the state to do the herbicide treatments. The herbicide will only be applied by the park frontages. He said it will be a challenging year because Lake Musconetcong is part of the Hopatcong State Park but receives no money for care of the lake. This is a political argument right now. He continued by providing details of the situation.

The Mayor felt that part of the problem is that the two separate groups taking care of the lake do not communicate (The Lake Board and the Homeowners Association). He provided an overview of the two groups and their different approaches. The Mayor is working on getting the two groups together which is challenging but will render a cohesive solution.

Councilman Hathaway continued to explain they are working with the senators and assemblyman to work on additional issues and solutions. He agreed with the Mayor that a cooperative effort is important.

OLD BUSINESS

No old business was presented

NEW BUSINESS

1. 2017 Budget Discussion

The Mayor noted that this process went fairly well. Councilman Still agreed. He reported that the increase is only about 2 cents per \$100.00. There was discussion about hiring another police officer but it was agreed this would cost too much at this time. When more money comes in it will be considered. Capital improvements are minimal this year.

Mr. Blakeslee reads the particulars regarding the Capital Budget.

The Mayor was made aware of one other item. The senior citizen group asked if there was a possibility of an increase since they have not received one in years. He feels this is long overdue. Councilman Hathaway explains this is due to a hardship.

PRIVILEGE OF THE FLOOR TO THE COUNCIL

Councilman Hathaway reported that he has tickets to sell.

MAYORS COMMENTS

The Mayor received a letter from the County Clerk in reference to the Cissy Laureys award, asking him to provide a recommendation for someone who has provided a lot of support to the citizens of the town. He has called Ms. Grossi to see if a Borough Employee could be considered. He also requested that the Council gives this some consideration.
