BOROUGH ADMINISTRATOR REPORT

Mr. Blakeslee provided the following updates:

 Pocketbook Factory – Met with the Borough Engineer and Mr. Wilensky and his engineer. There may be another method to deal with the easement with Norfolk Southern. The easement language in the agreement had some wording the developer did not agree with. The Planning Board may give our engineer the ability to make minor corrections to the site plan without amending site plan approval. The Mayor asked about the time frame. Mr. Blakeslee will try to get this on the March 27 Planning Board agenda.

 Community Development Grant Committee presentation - Mr. Blakeslee has been informally notified we will be receiving \$53,000.00 to do improvements at Arbolino Field.

Mr. Blakeslee noted an application for a \$243,000.00 grant from DOT last year. The funding amount has decreased but there is going to be discussion regarding funding on their March 13th agenda for us.

Mr. Bucco said they had a lack of applications this year and have gone back to some towns to provide additional funds.

The Mayor spoke about a situation where the DOT would like to change one of the 'right on red' lights in town to do not turn on red. He is not pleased about this. Mr. Blakeslee explained why this may be done. There is brief discussion among the Council regarding this matter.

Mr. Bucco has an update. He will be bringing a resolution to complete the in- rem foreclosures on the properties we had given him several months ago.

NEW BUSINESS

1. Social Affair Permit – Our Lady of Assumption Society – August 12th Feast

A motion was made by Councilman Still and seconded by Councilman Hathaway to approve this permit.

2. Shared Service- Mount Olive Library

Mr. Blakeslee provided an update regarding renewal. There is significant change to the agreement. He goes on to explain that the County Consortium will no longer allow residents of towns with no library to use the interlibrary use. In the past Netcong residents were only allowed to use their cards in the Mt. Olive Library. This will no longer be the case. All residents with cards will be forced to pay for the full service. The cost for the new cards would be \$250.00 each. Mr. Blakeslee provided the cost information from the previous years and the cost for the new program. He continued to explain the particulars of the previous agreements. One of the concerns with the new program is financially based.

Councilman Laureys asked why our residents could not just use the county library. Councilman Hathaway explained there are programs at the library that are not offered at the county. In addition, some residents do not have the means to get to the county library. The Council discussed the potential impact on the budget.

Mr. Bucco asked if the number of people signing up for cards remains fairly static. He suggested the Borough could charge a fee for residents to obtain the cards.

Councilman Hathaway asked if there is a cap on this. The Council continues to discuss the particulars of this situation.

Councilman Still says this will be difficult to fund since the budget has already been established.

Councilman Hathaway suggested we OPRA the library to find out how much they are paying for each card.

Councilman Laureys suggested we approach the Sussex County Library to use their library.

Councilman Sylvester suggested we write a letter to the Freeholders to ask about this.

There is concern that there will be no control regarding the amount of cards

issued.

Councilman Bucco suggests we could do an ordinance to limit the amount of cards issued.

PRIVILEGE OF THE FLOOR TO THE COUNCIL

Councilman Hathaway reported The Growing Stage held their benefit this past weekend at the Skylands which was very successful.

NEF hosted annual benefit at Knights of Columbus. \$15,000.00 was raised for the Netcong School.

There has been a conflict with scheduling between these two events in the past. It has been suggested to have an electronic regional calendar produced by the regional school board to show these events. He will request a letter of support from the Council for this calendar.

Councilman Still's only concern was that the borough already has its own town calendar. He was uncertain how all the information could be placed on one calendar.

Councilman Hathaway provided scenarios regarding this idea.

The Mayor asks how far ahead these events are planned. Councilman Hathaway replied that they are working together to try to avoid these conflicts.

The Council continued to discuss this matter. The Mayor suggested an electronic version or a link on our website and thought that it would be very effective. Councilman Still suggests many people do not use computers. The idea is for organizations to have access to each other's activities.

Councilman Koster asked if the Boy Scout in attendance tonight needs anything. He explained he is here to take notes for his citizenship and community merit badge. Caleb Clegg then approached the dais to explain what he is doing for his merit badge. Mr. Bucco asked how many badges he still needs
