MINUTES OF THE MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF NETCONG HELD APRIL 13, 2017 AT THE NETCONG MUNICIPAL BUILDING, 23 MAPLE AVENUE, NETCONG, NEW JERSEY COMMENCING AT 7:30 P.M.

Mayor Nametko called the meeting to order at 7:30 P.M.

# **PLEDGE OF ALLEGIANCE**

# ROLL CALL

Those in attendance were Councilman Hathaway, Councilman Koster, Councilman Laureys, Councilman Still, Councilman Sylvester, and Mayor Nametko. Also present were Mr. Blakeslee, Borough Administrator and Mrs. Eckert, Borough Clerk.

# **APPROVAL OF MINUTES**

No minutes were presented at this meeting.

# **PUBLIC PORTION OF MEETING**

Ms. Karin Amico, 52 Railroad Ave, began by addressing the Progressive Property Extension and the water issue on her property that was investigated last year. Mr. Blakeslee explained what had been seen when the property was looked at last year by the Borough Engineer, Administrator, and DPW Superintendent. He explained some of the possible resolutions suggested for this issue. The Mayor asked if she has something else she is looking for. Mrs. Amico claimed there was no testing or documentation to show where this water was coming from. She wanted to know if there is a dye test that could be done to see if the water is coming from Netcong Heights. She believes the source of the water is from water runoff from the Heights.

The Mayor stated that if there is an issue between two property owners they have to resolve it among themselves and the Borough would not get involved. He continued to say that the engineer and DPW had been out there several times. There did not seem to be water coming from the Heights. Mr. Canfield explained he had walked the property and he did not see any outlet pipe from the heights dumping water onto their property. Mr. Blakeslee added that the parking lots are pitched away from her property. Ms. Amico maintained that the water is not coming onto her property from the parking lot. Mr. Bucco wanted to verify that it is runoff from the parking lots of the heights. He continued that if that was the case, action would be against the heights because the height is private property. Ms. Amico wanted to know why the town is not concerned if there is flooding. She asked about the installation of additional drainage. Mr. Bucco explained if they did that for all properties that have problems the taxes would be very high. She continued to discuss the drainage issue. She would like to know if this issue could be resolved when Progressive Properties builds on their subdivision. The Mayor asked if there will be the installation of a catch basin where the new subdivision will be. Councilman Still asked if Ms. Amico wants the Borough to put a catch basin on her property. She responded "no," she wants a dye test done to see where that water is coming from. Councilman Hathaway asked if there is a planned basin on the other side of the street. The Mayor asked if she has tried any of the recommendations from our engineer. She responded by noting that this is a continual problem. Councilman Hathaway said some of the catch basins do continuously run. He explained that this problem is ongoing and getting worse. The Mayor asked if we have had tests done for leaks at the heights. Mr Canfield explains the leaks at the heights are usually readily noticeable and easy to find. The Mayor asked if we have the authority to go onto the heights property to investigate. Mr. Bucco said the Borough could send a letter to the heights asking to allow access to test this. If they do not agree to it, the Borough would not be able to access the property. Mr. Bucco provided details as to why the issues between two private properties cannot be handled by the Borough. Mr. Blakeslee offered to write a letter to Netcong Heights. The Mayor asked if Ms. Amico knows what areas she would like to have tested. The Mayor asked if they had water during the last dry summer. Councilman Still thought it was ground water. Mr. Canfield said it was runoff. Ms. Amico repeated that she wanted a test to prove the water is coming from the heights. She wanted to know if this water was running in the road what would the Borough do. Councilman Still stated there are many areas in town like that. We cannot dig on another person's property to put in a drain. There is further discussion on this issue. Mr. Bucco asked if the neighbors are getting water as well. She replied "yes." Councilman Still asked if it would be possible that one of the other houses has done something to cause the water to drain on her property. Councilman Still suggested that Mr. Blakeslee write a letter to Netcona Heights. Mr. Blakeslee will investigate and follow-up. discussion continued so the Council could get specific details from Ms. Amico.

Ms. Amico asked for an update on the Railroad Ave. street project. Mr. Blakeslee explained there was an issue with paperwork with the contractor for Railroad Ave. Phase I. For Phase 2, they are waiting for a DOT grant. The Borough needs to wait on DOT before going out to bid. The Mayor said the project should be done this summer.

The Mayor reviewed all the action items to be worked on moving forward.

With no others requesting to speak, Councilman Koster mad a Motion to Close the Meeting to the Public. Councilman Sylvester seconded the motion.

#### BOROUGH ADMINISTRATOR REPORT

Mr. Blakeslee provided an update on the library issue. There will be no change with MAIN policy. He recommended that the Borough notifies the Mt. Olive library that Netcong will not be renewing the shared service. He confirmed the Sussex County library would be \$50.00 per card with full service. We can also use the Morris County Library. It is disappointing that we will not be able to use the good services provided by the Mt. Olive library.

The Mayor explained his issue with MAIN. He feels it is the freeholders saving face by cutting off the funds for this to make it appear as though they are lowering taxes. Councilman Laureys asked how long it will take before Netcong can be set up with the Sussex County Library.

Mr. Blakeslee stated he did compose an OPRA request and got a response today that they would like an extension and are asking what our intent was. Councilman Still asked if Mr. Bucco could send the OPRA request. Mr. Blakeslee felt that the MAIN does not understand OPRA. Mr. Bucco stated there are negotiations with the Freeholders. Mr. Bucco will look at the OPRA request Mr. Blakeslee submitted and he will review and write a letter.

The Progressive Property issue was discussed. Mr. Blakeslee noted that there is a copy of the letter from the Netcong engineer in response to the concerns brought to light at last week's meeting. The Mayor suggested that the Council should ask for the additional bond. Mr. Blakeslee asked Mr. Bucco if the Council could approve the extension tonight with a condition. Mr. Bucco provided options and noted that if there is no extension, there could be a shut down. There is further discussion on this issue. Mr. Bucco suggested the Council approves the resolution with added information about the additional bond. Councilman Hathaway expressed concern that this project is going to improve some portions of the road that the developer was supposed to improve. There is discussion on regarding Councilman Hathaway's comment.
