1. Anna Madonna Letter – Retirement

Councilman Sylvester thanked Mrs. Madonna for her long-time service. She will be missed and hard to replace.

2. Dulari Sawhney Letter - Water Leak Incident

Councilman Hathaway stated we have not given relief to others in the past. We might write a letter explaining we understand his situation but we cannot give relief. However, we can work with him to set up a payment plan. Councilman Laureys asked if we should consult our attorney.

In response to Councilman Laurey's concerns, Councilman Hathaway suggested Mr. Blakeslee ask the attorney to write a letter to be voted on next week.

PRIVILEGE OF THE FLOOR TO THE COUNCIL

Councilman Hathaway offered that he will not be here next week. He would like to recognize all of those involved in the Holiday Parade. He provided specifics about some of the people and service involved.

Councilman Hathaway referred to the public portion of the last meeting and provided details about the school Color Run. He commented that he is grateful for the hard work that the Police Department did for this event.

Councilman Still said a policy is being worked on right now for future events like this and will be brought to the Council.

Councilman Sylvester thanked Sharon Still for orchestrating the Holiday Parade.

Councilman Sylvester noted that the NCP president was here last month and he is glad this organization has become everything it was meant to be. However, he is disappointed that the arrow on the sign was not done with arrowhead feathers. He was told by the wood worker who did the sign that the feathers could not be put on the arrow. He feels members of the NCP ignored the directive from the Council and did what they wanted and had the arrow head on the sign done differently than directed.

Councilman Hathaway was in agreement with Councilman Sylvester's concerns and explained what happened. Lengthy discussion ensued regarding the sign. Councilman Hathaway is working on fixing the sign.
