Ms. Dorothy Newman, Cross St.- Reported that there are four dogs in her neighborhood running free. They are urinating and defecating on other neighbor's property. This has been going on for years. Animal control has been notified many times and they have issued summons but the problem continues. She went into detail about this situation. She has called the police as well. She has even spoken to the owner of one of the dogs.

Ms. Patricia Leone – Amendola Ct. – Has the same complaint as Ms. Newman. She said the animals are quite aggressive when they are together. Mr. Blakeslee asked what time of day this happened. She said it is at all different times. She said this past weekend the dogs were chasing a neighborhood cat. She said the dogs wander at will. She provided extensive detail regarding the loose dogs. She wondered if the fine should be more aggressive. The Mayor asked if a complaint could be filed. The Police Chief will follow up with Tom Mendel tomorrow.

Mrs. Leone also complimented the DPW on the great job on plowing.

Dr. Ginter stepped forward representing the NCP on behalf of Stephen Fredericks, read a statement about the improvements made by the NCP in 2017. He requested a \$7500.00 contribution from the town for 2018. He offered to answer any questions the Council may have.

Mr. Blakeslee gave an update on the Crown Point project. The information arrived late so no action can be taken this evening. He noted Councilman Laureys found one discrepancy which will be adjusted. Councilman Hathaway asked if there was a copy of the rendered picture. The Council had a brief discussion on this topic.

Mr. Blakeslee noted that the monthly update on the infrastructure project was added.

The status of the cable agreement was also updated. Mr. Oostdyk provided information regarding the franchise operation in detail with the Council. The Mayor intervened to say the Borough had met with the new company Altice but they did not schedule another meeting. Mr. Oostdyk explained the process. The Mayor asked if we should wait for the public hearing to discuss issues with them or do we meet ahead of the public hearing. Mr. Oostdyk is hoping the hearing date will prompt them to contact us.

Councilman Still thanked Mr. Blakeslee and Jason for all the work they did preparing the budget. He explained we are waiting to introduce the budget and waiting on the Governor.

In the month of February 2018 the Borough had a total income in the amount of \$895,886.57 as compared to February 2017 of \$1,470,870.76.

#### Grants in Aid:

#### Taxes Collected:

The Borough collected \$883,316.42 in 2018 compared to \$1,462,646.02 in 2017

As mentioned last month two of the larger banks remitted I" quarter tax payments before the end of January in 2018 and those same banks sent their payments in February of 2017.

The Total Income Year to date for 2018 is \$2,025,925.88 as opposed to \$2,056,622.64 in 2017.

Councilman Albensi read the Recreation report.

- 2. Waitress Bus Trip sold out! (This Saturday March 10th).
- We are working on a few additional trips for this year -we have Feast of San Genaro already booked for Saturday Sept 15th; hoping to book 'Book of Mormon" in November and then possibly a Sands Casino Bus trip in June or July.
- 4. We are in the planning stages for our **"Kids Day"** to be held on Saturday June 9th. This event will include our annual color in the park contest, **DJ** entertainment, games, hot dogs, face painter, visits from the Fire Department (need to be asked) as well as Emergency Squad- event will be both educational and fun.
- 5. **Easter Egg Event with the PTA** will be held on Saturday March 24th from 1-3. Recreation will provide photos with the Easter Bunny and Cliffs Ice Cream.

The cost is \$40 per person with fundraiser proceeds (\$20 per person) going to our local church foodbanks. (St. Michael's, Grace Baptist, Methodist, First Presbyterian). If we sell out, which we should (40 people) the 4 churches will split \$800! We will also look for donations for those who cannot attend this event.
- 8. **Tai Chi** will resume on the first Saturday, April 7th.Tai Chi begins at 10 am and will run every Saturday thru the end of September. Classes in April will most likely be held at Boro Hall, unless weather will be ok at DiRenzo Park.

#### PRIVILEGE OF THE FLOOR TO THE COUNCIL

Councilman Still said we are waiting for our attorney's opinion on this topic. There was brief discussion on this issue. Councilman Laureys asked if we can say we follow the Federal laws and not singling out any specific industry.

#### **MAYOR'S COMMENTS**

The Mayor informed the Council that a letter was received from the Historic Preservation office. This party is holding up the Community Development Grant because it is saying Arbolino Park is a Historic site under Stanhope Borough. Mr. Blakeslee called the Historic office and they were not very agreeable. Mr. Blakeslee sent the information to Senator Bucco's office they will try to rectify this situation. Mr. McNeilly, Stanhope Administrator, will write a letter in our support. Councilman Still asked if this has to do with the Morris Canal. Mr. Blakeslee explained this will require an extra level of review. There is lengthy discussion on this issue.
