No. 2013-1 adopted on February 14, 2013), June 14, 2012 (Ord. No. 2012-13), August 9, 2012 (Ord. No. 2012-14), June 13, 2013 (Ord. No. 2013-8), October 10, 2013 (two ordinances: Ord. No. 2017-8), I have determined to issue a Bond Anticipation Note the "Note") of the Issuer in accordance with the following description:

- 2. Pursuant to said authority, I have awarded and will sell the Note to TBGC Investment Corp., at the price of \$1,976,119 plus an amount equal to the interest on the Note accrued to the date of payment of the purchase price thereof.
- 3. No obligations of the Issuer other than the Note have been issued pursuant to the bond ordinances referenced above and are now outstanding.
