Mayor Nametko called the meeting to order at 7:00 P.M.

MAYOR COMMENTS

Good evening ladies and gentlemen. On behalf of the Borough Council and our Borough employees, I would like to wish you Happy New Year.

Before I make my opening comments, we have a number of guests I want to recognize.

Before I discuss our many accomplishments in 2018, I would like to thank our Borough staff, our Police and Fire Departments, our Office of Emergency Management leader, the Department of Public Works and the Stanhope-Netcong First Aid Squad. With the combined support from these ladies and gentlemen, Netcong continues to be a great place to live and work.

On behalf of the Council I would like to thank every one of them. We are also very fortunate to have great volunteers on our Planning Board, Recreation Commission, the Netcong Alliance and Board of Health. My sincere thanks to every member of each group for their contribution to all of our residents.

2018

Every year for the past 12 years, I reported "it was a very busy year for our employees and volunteers". I am sure 2018 will be a hard year to beat as far as the number of projects we worked on and the increase in the services we provided.

ADMINISTRATION

This year, we completed the largest and most aggressive infrastructure project in many years. With financing from the **NJ Environmental Infrastructure Trust**, we made over 2 million dollars of repairs to our water storage and distribution system. In one way or another, every department in the Borough participated in the multi-year project. Simultaneously, our administrative staff played a major role in the early phases of two re-development projects.

You may remember I mentioned, two long time employees decided to leave the Borough office staff in 2017. I am glad to say, we hired two new full-time clerks to fill our accounts payable and water/sewer clerk positions. Our new water/sewer clerk is bilingual which improves the communication with our Hispanic residents who call or come into Borough Hall.

POLICE

Our Police department under the leadership of Chief Jim Blesson once again saw a record-breaking number of calls in 2018, including 6 NARCAN saves.

In September, one of our patrolmen stopped a truck on Main Street for exceeding the 6-ton limit. That stop netted a 50-foot trailer full of onions, over \$103,000 in cash and 44 pounds of Cocaine and Heroin with a street value of over \$1,000,000. Congratulations to the officers who took part in the arrest.

Looking forward, the Council approved Chief Blesson's request for an addition Sergeant position and an additional officer to his team. Our new officer is Netcong's first FEMALE, bi-lingual officer.

FIRE DEPARTMENT

Fire Chief Jack Sylvester III reported the Netcong Fire Department saw a 67% increase in calls in 2018. With a 142 call-outs last year, it seemed like a day did not go by without our volunteers being called upon for local help, mutual aid or RIC assistance. Whether it was 3 PM or 3 AM, when the call went out, our FD responded.

In March, our fire department received new TNT Rescue Tools by a grant from Firehouse Sub's Public Safety Foundation program.

After a14 month wait, and a couple of visits to the manufacturer by our truck team, our new fire truck was delivered in mid-December. Members of each fire company will be trained to operate the aerial ladder/pumper truck to insure it gets out the door in minutes, regardless of the time of day.

On behalf of Netcong residents and the mutual aid municipalities we server, I would like to thank all of our firemen, firewomen and the Ladies Auxiliary for the great job they do.

Department of Public Works

Under the supervision of Mike Canfield our Department of Public Works kept our buildings, streets and grounds in great shape. Along with their daily activities and emergency work, this small team planted and maintained our flower pots, kept our seasonal signage updated and decorated our light poles for Christmas.

Our DPW team had a role in every activity that went on in Netcong. Whether it is our Holiday Parade, Netcong Day or any other special event, they are there.

Besides all of these tasks, our DPW spent a great deal of time supporting our 2018 capital projects.

- Last year, our water infrastructure project kicked into high gear requiring our DPW works to assist the contractors on each task.
 - 1. We added 30 new and several replacement water cut off valves. This will minimize the number of residents affected by a water main break
 - 2. The installation of 25 new fire hydrants.
 - 3. We installed new water main along Rt. 46 between Flanders Road and Love Lane.
 - 4. Also, as part of the project, we completed replacement of every water meters in the Borough.
 - 5. And finally, our old reservoir on the top on Center street was demolished and filled in.

- Thanks to a NJDOT grant of \$150,000 we also completed all of our street and sidewalk improvements as part of a multi-year project on Stoll Street and Marc Court.
- As you can see, we accomplished a lot of capital projects in 2018. Our DPW team had a hand in every one of them.

-----2019 Projects -----

- Frankly, one of our disappointments in 2018 was the delay of the **Phase 1**Arbolino Park Enhancements.
- 2017 **CDBG** of \$80,000. funded project by а That İS came in much higher than anticipated. Unfortunately, bids our

We expect to bring the bids in to line this year by separating the project into 3 Requests for Proposals.

- o Resurface both tennis courts, convert one to a BB court.
- New fence around the courts.
- New lighting on both courts
- In 2018 we were successful in getting another CMBG grant for \$80,000 for Phase 2 of the Arbolino Park Enhancements. We expect to go out to bid to this year.
 - Resurface ½ of the old Basketball court for our pickle ball wall install new senior friendly/ADA compliant exercise equipment where the other half of the basketball court is today.
- In 2018, we received a \$220,000 NJDOT Grant for the resurfacing of Carolyn Way, Lower end of Wiltop Road and Oak Street. We expect to go out to bid for that project this year.

Economic Development

Our Economic Development Committee spent over two years in meetings with the developer and the NJDEP working on our first redevelopment project. On Saturday, December 30th, the Council approved the final step of the **34 BNK** project. I am glad to say the builder; CROWN POINT will begin demolition of the building on the Quirk property in the next several weeks to make room for their new 126 unit complex with construction to start soon after. The **34 BNK** apartment complex is walking distance to the train station and will be a big boost to all of the businesses in Netcong.

The 'Pocket-Book Factory Property' redevelopment project also looks like it may have a 2019 ground breaking. This project, pending Council and Planning Board approval, will consist of 80 apartments in walking distance to our train station and it too will help our downtown businesses.

So, it looks like it will be another busy year in Netcong this year.

I wish I had something positive to report on the Transit Village. However, we are no further along with NJ Transit than we were at this time last year.

Our downtown looks great thanks to the support by the Netcong Community Partnership.

Our Recreation Commission continues to add programs including 26 weeks of Tai Chi and bus trips to NYC events.

Lake Musconetcong looks great thanks to the volunteer members of the Lake Musconetcong Regional Planning Board and the Lake Musconetcong Community Association.

We are improving both of our parks with funding from CDBG grants.

We enhanced our police department and invested in a state-of-the-art fire truck.

All of this for our current residents and those who will call Netcong home in the near future.

Thanks to all of our employees and volunteers, Netcong continues to be an attractive place to live and work. We are all dedicated to keep Netcong a great community for our current and future residents.

Wrap-up

We are a small town, with a big heart and I am proud of what we accomplished in 2018.

Thanks again to our office staff, Fire Department, Office of Emergency Management, Police Department, First Aid Squad and all of our volunteers.

I would like to thank the Netcong Council for all of their hard work last year, their continued support and, dedication.

After discussions with my wife, Olivia, I am announcing today that I plan to run for ONE more term as your Mayor. If I am successful, my next term will be my last term as the Mayor of Netcong Borough.
