MINUTES OF THE MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF NETCONG HELD JULY 11, 2019 AT THE NETCONG MUNICIPAL BUILDING, 23 MAPLE AVENUE, NETCONG, NEW JERSEY COMMENCING AT 7:30 P.M.

Mayor Nametko called the meeting to order at 7:30 P.M.

PLEDGE OF ALLEGIANCE

STATEMENT OF OPEN PUBLIC MEETINGS ACT

Those in attendance this evening were Councilman Albensi, Councilman Hathaway, Councilman Koster, Councilman Still and Mayor Nametko. Also present were Mr. Blakeslee, Borough Administrator and Mrs. Eckert, Borough Clerk.

APPROVAL OF MINUTES

A motion was made by Councilman Still and seconded by Councilman Albensi to approve the minutes.

PUBLIC PORTION OF MEETING

Mr. Ray Sylvester - 129 Ledgewood Ave. read his letter (he had previously dropped off to Borough Clerk) to the Council. (Letter is posted in the Correspondence Section) In response to the details in the letter, the Mayor said new larger signs were ordered. Mr. Sylvester stated that is not enough. He said there are trucks that stay in the Knights parking lot all night long with their vehicle running. He would like to get the DOT involved. He gave details about the situations he has been dealing with for a long time. He requested traffic be diverted down the other side of the hill instead of through Netcong. The Chief confirmed the trucks parking at the Knights can be ticketed and towed because they are on private property. He gave further details on the situations that occur each day. Mr. Blakeslee let the Mayor and Council know he had written a letter to Roxbury about Netcong's position with this situation. The Mayor said we had contacted Roxbury about moving the trucks down to the other side of the hill and met with disagreement. Mr. Sylvester stated there are not many homes on that side of the highway which would make more sense. There was continued discussion on this subject. The Mayor agrees with Mr. Sylvester's complaints. Mr. Bucco asked if Mr. Blakeslee has spoken with the Roxbury town manager. Mr. Blakeslee stated he had. Mr. Bucco said the DOT could be contacted but they may have issues because of the commerce rules. Mr. Bucco feels many of these existing rules are grandfathered which is why they now have to get variances. Councilman Still suggests Mr. Sylvester go to the Planning Board meeting in Roxbury to complain about the current situation. Mr. Bucco asked the Chief of Police if we can get a report on the number of traffic accidents that have occurred in that spot.

The Chief stated that he could do a traffic survey. Mr. Dellamo (in audience) stated the State Police will provide a report within 2 weeks. There is lengthy discussion on this subject. Mr. Sylvester stated it is the local truckers that cause the most problems. Councilman Hathaway stated the owner of the PILOT property is willing to put a sign directing the trucks to the other side of the location. The Chief will go ahead and complete a traffic study. The Mayor asks if we can write summons for these trucks. The Chief requested that Mr. Sylvester call the police instead of trying to handle these things on his own. Mr. Blakeslee will contact Roxbury for an update on the status of this project.

Mr. Ben Dellamo-30 Church St. – Mr. Dellamo spoke to Mr. Blakeslee about old reservoir lot which is near his house. Mr. Dellamo asked if this could be sold to the surrounding neighbors without going to auction. Mr. Dellamo asked if subdividing creates a hardship so the Borough can sell the lot. Mr. Bucco explained how this lot can be sold. Mr. Bucco gave an explanation of the options that can take place to sell this property. There was discussion between Mr. Dellamo and Mr. Bucco. Mr. Bucco would have to do a bit of research on this. The Mayor gave comments on the reasons for the Borough wanting to sell this property. There is lengthy discussion on this subject. Mr. Bucco made a drawing for Mr. Dellamo to give details on how this would be done. They would be selling small pieces to eliminate encroachments and then selling the remaining lot by auction. Mr. Dellamo asked about access. Mr. Bucco stated there

would still be access through the existing road. There is further discussion on the details of this property. Mr. Dellamo asked when this will be done. It was explained to him the search took a while to do but a map was made to show the plan. There was further discussion between Mr. Bucco and Mr. Dellamo. Mr. Bucco explained this plan is to help the adjacent property owners to eliminate the easements. The Mayor explained this will take time to complete.

CORRESPONDENCE

1. Letter - Ray Sylvester- PILOT Gas Station

To the Mayor and Council,

My name is Ray Sylvester. I have resided at 129 Ledgewood Ave. for the past 25 years. I understand that The PILOT is currently looking to expand its operations. I also understand that the Boro of Netcong has sent an official letter, stating their dissatisfaction for this application. I think it's time to stop asking Roxbury to do certain things when clearly they will do what benefits them. I believe that we should tell Roxbury to start doing what we want!! For starters demand they put signage instructing all trucks to exit right and to continue onto 46 east to get back to route 80 where 90 percent of the traffic is going. Who ever heard of a truck stop over a mile off of the interstate? Well Roxbury does, and it doesn't matter to them since they are not affected one bit by this. Let some of the traffic roll down their side of the hill, this alone will cut traffic by almost 50%! We bear the brunt of the traffic and the noise yet receive no benefit at all. Maybe it's about time we involve the DOT for some ideas, to reduce the speed of the trucks and proper signage at the top of the hill or anything else that can help. We have a "no jake brake" ordinance in town and the sign is barely visible from the road. A lousy 12x18 inches, no one can see when there flying down the hill. I asked Chief Blesson to put the digital sign at the new intersection and he does, but sometimes other things take precedent. Why can't we look to a large permanent sign for starters and then call onto the police to enforce the ordinance among other things that have to do with the trucks? I know some of you are going to say that I live on a "highway" but it has become an entrance and exit ramp for the PILOT. All hours of day and night trucks rumble up and down the hill, I have personally chased trucks who make Route 46 their personal rest stop at all hours of the day and night. I invite any and all of you to come and sit on my porch and see what my "quality of life" and living at 129 Ledgewood Ave. has become and see for yourself. Mr. Bucco what are you going to do for the people of Netcong concerning this matter? I understand you also represent Roxbury and this matter might be a conflict of interest. Well it's not for me. We pay you to represent us and you should do just that. Roxbury always sticks its crap on the outside of town so as to not impact the "good" citizens of Roxbury, but not really caring about its surrounding towns as neighbors. If Artie Ondish were here, he would agree 100%.

BOROUGH ADMINISTRATOR REPORT

Mr. Blakeslee had one addition: there was flooding at Tony Tank and some issues were found on the property that needs to be abated. The property owner has requested help to clean the pipe that is on his property causing the flooding. The question is if the Borough should be going on this property to do repairs since it is private property. There is a culvert which can be a danger when filled with water. Mr. Canfield, DPW Superintendent, explained the details of the culvert and where the water is coming from. Councilman Hathaway asked for detail of where the water is coming from. Councilman Hathaway provided details on previous flooding in that area. Mr. Canfield added details about the water in that area. Councilman Still wondered why the bar owner has not complained since her parking lot gets flooded. Sgt. Coppalella explained the current situation there. It is agreed this has nothing to do with Tony tank and the town should clean it up as it is a byproduct of a previous road project. Mr. Canfield said we do not have the proper equipment to clean this area. It is too large. Councilman Hathaway asked if we did the cleaning at the end of Hilts Lane which is a similar situation. Mr. Canfield gave examples of other clean up but these were different situations. The current blocked pipe is large and not easily cleaned. Mr. Bucco stated we cannot just go on private property to do this work. We have to get a temporary construction permit to do this repair. Councilman Hathaway asked what needs to be done to fix this. Mr. Bucco provided explanation. Mr. Canfield stated it is not known where the blockage is. There was further discussion on this. Mr. Canfield expressed concern about going on private property. This is why this situation has been brought to the Council's attention. Mr. Bucco is concerned about the Borough going onto private property. Mr. Bucco asked if a camera could be run through the pipe to see where the blockage is. The Police Chief and Mr. Canfield will go to the property tomorrow to have the owner put a plate over the opening. Sgt. Coppalella gave explanation of the current details of the area. The Police Chief is concerned someone will get hurt. Mr. Canfield wanted direction on how to handle this situation when he goes there tomorrow. Mr. Bucco reminded the Council if the Borough puts their own cover on it the Borough then becomes liable if there is a lawsuit. Councilman Hathaway suggests we require them to cover the culvert. There is heated discussion among the Council.

A Motion to fix Culvert located at Long Street (Tony Tank) after permission is granted via temporary permit for Mr. Canfield to be on the property was made by Councilman Still and seconded by Councilman Hathaway.
