MINUTES OF THE MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF NETCONG HELD AUGUST 8, 2019 AT THE NETCONG MUNICIPAL BUILDING, 23 MAPLE AVENUE, NETCONG, NEW JERSEY COMMENCING AT 7:30 P.M.

Mayor Nametko called the meeting to order at 7:30 P.M.

PLEDGE OF ALLEGIANCE

STATEMENT OF OPEN PUBLIC MEETINGS ACT

The Borough Clerk read the following statement:

ROLL CALL

Those in attendance this evening were Councilman Albensi, Councilman Hathaway, Councilman Koster, Councilman Laureys (arrived 7:31,) Councilman Still, Councilman Sylvester and Mayor Nametko. Also present were Mr. Blakeslee, Borough Administrator and Mrs. Eckert, Borough Clerk.

APPROVAL OF MINUTES

No minutes were presented at this meeting.

PUBLIC PORTION OF MEETING

Dennis Lestreng 43 Prospect Hill Rd. Kennebunkport Maine 12729. He wanted to inform the audience about genocide by scalpel in China. He explained this has to do with organ donation. People including US visitors are being killed in China for their organs. He is here to make the Council aware of this situation. He provided packages for the Council members. He is asking for a resolution to be executed.

ORDINANCE ADOPTIONS

1. Ordinance 2019 -14 - An Ordinance to Amend Chapter 268 – "Vehicles and Traffic" of the Revised General Ordinances of the Borough of Netcong Providing for a Penalty for Violation of Heavy Vehicle Exclusions and Identifying Additional Roadways Subject to a Heavy Vehicle Exclusion

Councilman Still asked the attorney to provide more information regarding this ordinance. Mr. Bucco explained the laws in place to deal with this situation and the details on how to do what they want. He explained we cannot ban large trucks in our town. The process to do that is lengthy. Councilman Hathaway asked if we can put a limit on just the local roads. Mr. Bucco said after doing extensive study, he does not feel this in enforceable. He provided an actual example regarding a road sign. Mr. Bucco said we can do what the Council wants but it does not mean we can enforce it. Councilman Hathaway asked about a federal regulation and how that works. Mr. Bucco gave description on his knowledge of that. He explained the ordinance as it is would be the quickest way to get this done. They can do something additional later. He explained litigation costs can add up quickly. He doesn't want to do an ordinance that will not work well for the Borough. The Mayor asked if we want to include certain roads, we can put up signs. Mr. Bucco said yes. He also stated more roads can be added later. There was discussion among the council on what types of roads could be included Mr. Bucco suggested this ordinance be adopted tonight. If there is a problem down the line, we can amend the ordinance later. Mr. Blakeslee explained this ordinance has a \$500,00 fine which was not included in the past.

A Motion to Read Ordinance 2019-14 by Title Only on Second Reading and a Hearing Held Thereon was made by Councilman Still and seconded by Councilman Hathaway. Roll Call: 6 Yes

The Mayor opened the meeting to the public. No one stepped forward.

A Motion to Close Public Hearing was made by Councilman Albensi and seconded by Councilman Koster.

A Motion to Adopt Ordinance 2019-14 was made by Councilman Still and seconded by Councilman Hathaway.

CORRESPONDENCE

BOROUGH ADMINISTRATOR REPORT

Mr. Bucco had one question about the contract for safe routes to schools. He has not received the signed contract. Mr. Blakeslee explained there is extra wording that needs to be added for federal government standards.

Councilman Laureys asked what happens if we don't get a bidder for the ADA doors. Mr. Bucco explained the process.

Mr. Blakeslee stated that we got a copy of the ordinance with our terms and conditions from our Borough Attorney today. He will be sending it for approval with the cable company. He is hoping we can resolve this issue soon. Mr. Bucco gave explanation of the process of this ordinance. There was continued discussion among the Council on this subject.

Councilman Still read his report and provided a comment/explanation on a question about the vacant properties raised by Councilman Laureys. The Mayor said in the past we offered tax abatements but that did not go well.

Councilman Hathaway reported that August 28th is ground breaking ceremony for Crown Point/Quirk property. It is a great accomplishment.

Pocketbook Factory - we have the PILOT and Developers Agreement - the committee will have a meeting with the developer to make the best deal possible for the Borough. The Mayor stated it would be advisable to get the owner to the meeting not just his attorney.

Correspondence was received from Shop Rite relative to their project. There is still a large disconnection between the Borough and Shop Rite. The EDC met with the Borough Engineer and Planner recently to review comments on the draft redevelopment plan submitted by ShopRite's attorney. There is still some work to be done before this can come before the Council.

PRIVILEGE OF THE FLOOR TO THE COUNCIL

Council President Koster received a request from the Recreation committee to paint lines in the parking spaces at DiRenzo Park. Mr. Bucco said if it is our property, we can do it. Mr. Canfield asked for the proper sizing to paint the lines and he would complete the task.

Councilman Hathaway reported that the weeds in the lake have been tested. They are clean and can be disposed of at this time. The equipment repair is complete and weed removal will begin again next week. There is hazardous algae bloom in the lake. The state will be testing twice a week. Mr. Bucco asked what the level was. Councilman Hathaway stated it is not spread throughout the lake; it is only in small sections. Mr. Bucco Noted that extensive research has been completed on this issue. He explained Lake Hopatcong is above the state standard. He has been arguing with the DEP about what a safe level is for people to stay out of the water. He continued to elaborate on this. In his opinion there is no reason to shut the lake down at this time. Councilman Albensi asked if there is any money coming to the lake committee to remove the weeds. Councilman Hathaway stated the lake is not as good as it should be due to money constraints.

Councilman Sylvester asked about speed tables. Mr. Blakeslee said it has been put on the back burner due to more important matters. He gave details on what has been discussed and some of his suggestions. The Council agreed with Mr. Blakeslee's ideas. The Mayor suggested we order the sign and put it up. Councilman Sylvester asked if we would have to do an ordinance for this. It was agreed this was easy to do. Councilman Still is concerned because the town will become liable because it does not comply with the State rules. There is discussion among the Council on how to get this done. Councilman Laureys asked why the legislature gets in the way of towns making decisions for their own roads. Discussion continued regarding the speed tables. Councilman Sylvester will poll the residents on Stoll St. and College Ave.

A Motion to have the Borough Engineer makes an application to the state for a stop sign on Stoll St. by Councilman Hathaway and seconded by Councilman Koster. Roll Call: 6 Yes
