2. Mr. Blakeslee commented on the Tony Tank property and gave some detail on recommendation to do a title search. He asked Mr. Bucco to do a title search on all properties involved to see if there is an easement on that property. The estimate given for the search is \$1,800.00. He gave detail on how we can pay for this. There was discussion among the council on the purpose for doing this title search.

A Motion to approve Mr. Bucco to do a title search on the affected properties associated with the Tony Tank property not to exceed \$2,000.00 was made by Councilman Hathaway and seconded by Councilman Sylvester.

Councilman Sylvester stated it was his understanding all town owned buildings would have internet and telephone service at no charge. It does not appear to be in the final contract. There was discussion on the details of this. Mr. Blakeslee contacted the representative from the cable company and asked for clarification. Councilman Still provided his opinion. Mr. Bucco explained this is no longer regulated. It is controlled by the FCC and only the television portion. He explained the internet portion is totally unregulated. He expects pricing to change. Councilman Sylvester asked if we can find another provider. Mr. Bucco gave explanation on that subject. There was detailed discussion among the Council. Mr. Blakeslee will contact the cable company to clarify we already have the lines we just don't want to be charged.
