BOROUGH ADMINISTRATOR REPORT

Mr. Blakeslee stated the AFS has been completed and put on the website.

Regarding Mr. Ruschke's report on the Arbolino Park Trail Opening: this will be on the March agenda for approval of the contract. He gave some details on the bidding process.

There was discussion about reimbursements from the recent nor'easter snow storm. Some details were provided on this subject.

The Mayor suggested we try to get money for the broken plow.

The cost of snow removal for Maple and Main came to \$10,000.00. Funds from the Snow Trust will be used.

Finance & Insurance:

Councilman Sylvester filed his report.

For the month of January 2021, the Borough had a total income in the amount of \$577,569.10 as compared to \$1,571,610.65 in January 2020.

For the month of January 2021:

Miscellaneous Revenue Not Anticipated (MRNA):

In 2021 the Borough received \$1,877.04 compared to \$1,517.45 in 2020

Other Licenses/Borough Clerks Fees:

The Borough received \$19,869.35 in 2021 compared to \$27,912.23 in 2020. This difference is from lower interest rates and lower Municipal Court Fees collected.

State Aid:

In 2021, we received nothing in state aid. There was no state aid received in 2020 either.

Grants in Aid:

There was \$1,297.98 received in Grants in Aid for 2021 and \$1,423.28 in 2020.

Taxes Collected:

The Borough collected \$554,524.73 in 2021 compared to \$1,540,757.69 in 2020. This difference is due to the timing of payments from most of the mortgage companies. The payment for 2020 was made in January while the payment in 2021 was made in February.

Income Total Year to Date:

The Total Income Year to date for 2021 is \$577,569.10 as opposed to \$1,571,610.65 in 2020.

Economic Development: R. Hathaway E. Still

Councilman Hathaway reported that they are taking action on the PILOT for Shop Rite. The appraisal for the parking area property is approx. \$100,000.00. This has been passed on to Shop Rite for review.

The Crown Walk has filed permit applications for footings so a groundbreaking should be coming soon.

Public Safety:

Councilman Koster read the reports and stated the new special will be at the shooting range for qualifications.

The Mayor commented there were 40-45 fireman being trained for ice safety training. He was very impressed with the 2-day training. Councilman Koster participated in the training and stated everyone was had done a great job going into the cold lake. Councilman Koster stated we now have 12 certified technicians for this. Councilman Koster said this course was very enlightening and informative.

PRIVILEGE OF THE FLOOR TO THE COUNCIL

Councilman Hathaway wanted to echo what a great job the DPW and Police did dealing with the largest storm NJ has seen. None of the roads were ever impassable at any time during the storm.

There is an issue on Allen St. near Rosie's. Snow is falling off the roof into the sidewalk and roadway. It is a public safety hazard. There is a lot of pedestrian traffic there and something needs to be done. Councilman Hathaway wants to see something done. Mr. Blakeslee suggested we close the sidewalk in that area. There was brief discussion among the Council on this subject. The Mayor suggested we call the building owner to have this remedied. There was discussion about updating our code to make sure metal roofs have a guard to prevent slide.

Councilman Hathaway stated there was an informal meeting about salaried employees

be paid hourly overtime for the recent storm. He stated he talked with the DPW Superintendent who stated he would be making less money than those under him because he cannot be paid overtime. Councilman Hathaway feels we need to do something to compensate these employees who have gone above and beyond. He suggested a policy be done to pay these employees overtime in the event there is a reimbursement. Councilman Sylvester suggested maybe we attach it to anything that is created as a state of emergency. Mr. Bucco provided the details regarding the laws and reimbursements. Councilman Hathaway feels we need to come up with something different than what we have done in the past.

Mr. Anthony stated when there is FEMA money available every county has to meet a certain dollar threshold. Even though the state of the emergency is called it is not always a guarantee you will get FEMA money. He stated there were 2 different answers about salaried employees. If it is out of the scope of his regular duties, he can be paid. He gave other details about the laws, etc. He said any of these things can change and gave details of different scenarios that have happened. There was discussion among the council on the particulars of this subject. Mr. Anthony gave details on the process of payment. Councilman Hathaway asked the Borough Attorney what can be done. Mr. Bucco said research would have to be done on this before a motion should be made on this.

A Motion to have the attorney research and make a recommendation to remedy the issue of overtime to salaried employees for storms such as the Nor'easter just experienced was made by Councilman Hathaway and seconded by Councilman Sylvester.
