For the month of February 2021, the Borough had a total income in the amount of \$1,875,760.56 as compared to \$852,023.49 in February 2020.

For the month of February 2021:

Miscellaneous Revenue Not Anticipated (MRNA):

In 2021 the Borough received \$11,568.75 compared to \$37,480.10 in 2020 This difference is a result of lower Construction Fees collected in 2020.

Other Licenses/Borough Clerks Fees:

The Borough received \$4,748.62 in 2021 compared to \$13,273.41 in 2020. This difference is from lower interest rates and lower Municipal Court Fees collected.

State Aid:

There was no State Aid received in 2021 or in 2020.

Grants in Aid:

There was \$2,880.46 received in Grants in Aid for 2021 and nothing in 2020.

Taxes Collected:

The Borough collected \$1,856,562.73 in 2021 compared to \$801,269.98 in 2020.

Income Total Year to Date:

The Total Income Year to date for 2021 is \$2,453,359.12 as opposed to \$2,423,634.14 in 2020.

Councilman Still stated this will be the tightest budget ever completed.
