PRIVILEGE OF THE FLOOR TO THE COUNCIL

Council President: Thanked Fire Dept. and emergency workers for their work yesterday and today with the cleanup from tropical storm Ida.

Councilman Laureys: Would like to discuss the ordinances for hedge brush and smoking. He states the brush and hedge ordinance mentions emergency situations — what types of situations constitute an emergency. Councilman Hathaway stated a fallen tree would be an example. There was discussion about the reason for the wording in ordinances and how they are designed to cover as many situations as possible. Councilman Hathaway has a concern about the definition of encroachment- he feels it needs to be specific and defined. He provided an example which was 'six inches from the sidewalk. '

Councilman Laureys has concerns over the cost of the fines for smoking in public areas. He feels the fees are excessive. He feels the initial fine should be less. Mr. Blakeslee stated he is under the impression the state statute maintains that the minimum fine is \$250.00. The mayor gave an example for the reason behind the fines. There was lengthy discussion among the Council on this subject. Mr. Blakeslee checked our current code which has a minimum penalty of \$100.00. Councilman Still asked if anyone else is opposed to this fine amount. Councilman Hathaway stated we are talking about our parks where there will be children. The mayor asked for a poll of the Council members. A "yes" vote would indicate the Council agreed to keep the ordinance as is with no changes.

Roll Call: 5 Yes No: Councilman Laureys

Councilman Albensi: There is a bee problem at the clubhouse at Indians Field. We need to notify Mike Canfield.

Councilman Hathaway: The swirl chamber is now out of spec as per Mr. Canfield.

He received pictures from Crown Point there was no issues with the drainage during yesterday's storm (IDA)

Councilman Hathaway asked about Mr. Cedro's property during the storm. Mr. Blakeslee stated there were no issues.

Councilman Still asked if there was flooding at the old circle. Mr. Blakeslee stated no but there were issues on McMullen and Helen Way due to the DOT yard. We are going to perform road work on Helen Way and there is concern this will affect that work.

MAYOR'S COMMENTS

There is a production company interested in using DiRenzo Park gazebo on Sept. 18th from noon to 3 to produce a trailer. Councilman Koster asked what type of movie they are promoting. There was discussion regarding not allowing the use of the park on a Saturday when children will be in the park. The mayor stated we would need police there as well. Mr. Blakeslee gave the synopsis of what the trailer would be. Councilman Still stated we do not have an ordinance to charge them for the usage of the park. There was discussion on the details of the event. It is suggested they come on a Friday during the day when children are not present. Mr. Blakeslee will ask for more detail of this before the Council makes a decision.
