MINUTES OF THE MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF NETCONG HELD MAY 5, 2022 AT THE NETCONG MUNICIPAL BUILDING, 23 MAPLE AVENUE, NETCONG, NEW JERSEY COMMENCING AT 7:30 PM.

Mayor Nametko called the meeting to order at 7:30 PM.

Those in attendance this evening were Councilman Albensi, Councilman Hathaway, Councilman Morton, Councilman Laureys, Councilman Sylvester, Councilman Still and Mayor Nametko. Also present were Mr. Blakeslee, Borough Administrator and Mrs. Eckert, Borough Clerk.

NETCONG BOARD OF EDUCATION TO ADDRESS THE COUNCIL

Netcong School Budget

Mrs. Bernadette Dalesandro, President of the Board of Education here with, arrived with Ms. Kate Walsh and Mr. Paul Stabile, Business Administrator. She would like to thank the police department for coming to the school to meet about pick up and drop off of students to make it safer for all.

Ms. Kate Walsh, School Superintendent stepped forward to give her presentation. She detailed the accomplishments for the 2021-2022 school year. She explained all the activities that were restored after the Covid crisis. The air purifiers that were in every classroom and offices have all been paid for. She continued reviewing the details of these accomplishments and changes for the past school year. They have done presentations

in Nashville and other states and towns for the RTI program. They implemented a therapy dog program this year. They upgraded the security system.

Ms. Walsh provided their goals for the upcoming school year.

Mr. Stabile, Business Administrator, gave his presentation on the financial side of the school budget. He explained there is a new program: if the district showed a savings, those funds would go to the taxpayers; which they accomplished. He explained a program for out of district students. Three students qualify for this. He went over the costs for the school and the grants available to the school.

Mrs. Walsh reviewed the shared services the school uses with surrounding towns.

Mr. Stabile reviewed budget numbers for the upcoming year. He provided details about the debt service. He went on to give details regarding the proposed capital projects. He gave the tax impact numbers. Mrs. Walsh stated they are maintaining services, staffing and technology.

Mrs. Dalesandro asked them to explain what ESSER funds are. These were for Covid relief funding.

Councilman Sylvester asked how many students they have. Mrs. Walsh stated 285. They stated that the number of students coming to our school from other districts is 13. Mrs. Dalesandro stated the K-4 program is fully funded by the state, no local tax money is used for this program. There were requirements that were met. There are 24 students that use this program. Councilman Sylvester asked about the consistency of the budget, since so much of this money is not paid by the local taxpayer. Mrs. Walsh stated they are very careful about how they are using the grant money. He was concerned this may be a problem. If the state stops providing funding, this will impact our residents. Mrs. Dalesandro stated they have used the money for permanent changes that should not impact the tax payer in the future. The mayor thanked them for their time.

PUBLIC PORTION OF MEETING

Mr. Pat Kunkel,13 Church St., had questions about the proposed project on the Church property. He is concerned about this large project and he is against it. It is zoned a single-family zone. This is a residential area which cannot handle the size of this project. The traffic on Church St. is already out of control. To add 88 residential units will overwhelm the already difficult situation. He can understand the pocketbook factory and 34 bank units make sense because they were industrial zones. He is here to give his opinion on this possible project. The mayor thanked him for his time.

PRIVILEGE OF THE FLOOR TO THE COUNCIL

Council President: The Fire Dept. committee is putting together a new truck proposal — there is a 2-year build on this truck — he gave details on this subject. \$750,000.00 or so is the cost for a new truck. The mayor asked if they would be doing a presentation. Councilman Sylvester stated they are not ready yet. Mr. Blakeslee asked if there is a trade program for this. The truck they want to replace is starting to show wear and tear but it will have value as it has been maintained. Councilman Laureys asked how much money has been put aside for this. The response was \$25,000.00 has been put aside for the past few years to help cover the costs. Councilman Laureys was concerned we are not putting enough money aside for this. There was discussion among the Council on this subject and the state of the current budget. Councilman Sylvester will get information on the financing plan. Councilman Still stated we will be paying for these trucks for years. There was discussion among the Council on the details of financing of this new vehicle. Mr. Blakeslee detailed the process of long-term capital costs and expenditure. Councilman Sylvester stated the equipment on the truck will not need to be replaced.

Councilman Albensi: asked when the possible new member of the recreation committee will be considered. The recreation commission is thin now. The current members are not putting as much effort in as needed. They need extra hands. We need to post recreation positions that need to be filled immediately. Councilman Still stated we need members who will do the work needed.

Mr Blakeslee wanted to mention that this is clerk's recognition week this week. He wanted to report that Mrs.Cindy Eckert is a very strong asset to the Borough.
