BOROUGH ADMINISTRATOR REPORT

No additions –but bringing attention to the proposed cap relief bill and the importance of this bill.

Mr. Gabloff, CFO, stated that this is the league legislative committee right now. He explained the details in this bill. He stated this would be helpful with budgets going forward. There was discussion among the Council on this issue. Senator Bucco stated he has not seen the bill yet. The league is hoping to get this bill to the legislators before the 2023 budget season comes. There was additional discussion on the particulars of this proposed legislation and the pros and cons of this issue. Mrs. Dolan stated this has already affected the smaller communities but it is now happening in the larger communities. She gave details on this issue. This bill would give flexibility during inflationary times. Mr. Gabloff stated this is becoming a large issue for many communities. There was further discussion on this issue and the difficulty it causes.

One more related issue is we buy our natural gas and electric from a co-op and the price increases are large with the bids that came in. He provided details on this issue as well.
