A motion was made by Councilman Hathaway and seconded by Councilman Still to approve the above noted resolutions.

Councilman Sylvester stated this is another time we are going with another engineering company instead of our own engineer. There was discussion among the council on this matter. Councilman Hathaway stated he has had issues with our current engineer. There was further discussion on this issue. The mayor suggested we do an RFP. Councilman Hathaway provided several other comments on the issues with this engineer. He provided the details on several incidents. Mr. Blakeslee offered additional comments on a particular application involving our engineer. Councilman Hathaway stated he ended up doing the work for this application. Councilman Still stated we need a firm that we can rely on for all our engineering services. We can't be hiring multiple engineers. Councilman Hathaway stated we have had several incidents where we have not received grant money available due to the engineer missing the deadline. There was discussion on the number of applications that can be submitted. Councilman Hathaway gave his opinion on the issue. Councilman Sylvester asked if the engineer that started this project could complete it. The mayor suggested we could do a professional services contract to get this completed. Councilman Hathaway stated this grant is money that we could be putting to good use.

Councilman Laureys asked about the difference between resolution 118 and 119. Mr. Blakeslee explained the difference in detail.

PRIVILEGE OF THE FLOOR TO THE COUNCIL

Councilman Albensi asked about the winter parking he had brought up at the last meeting. Councilman Sylvester stated the police chief did not have an opinion one way or the other. The mayor had several comments on this. There was a brief discussion on this subject. Councilman Hathaway stated our attorney was going to bring some information about what other towns do. He would be an advocate for the strongest language for when it is snowing and allow the police to determine the ticketing. There was further discussion among the council on this subject and the need for flexibility. Mr. Blakeslee will contact our attorney.

Councilman Laureys would like the council to reconsider surveying the town on the subject of the St. Michael's project. He suggested a survey monkey and a link on the website. He feels since this is such a contentious issue, he would like to wait until Councilman Morton is here. Councilman Still said he would just need to make a motion. He asked the council to think about it. The mayor had several comments on this subject and mentioned land use laws. Councilman Laureys made a comment regarding this.
