BOROUGH OF NETCONG

MINUTES OF THE MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF NETCONG HELD JUNE 1, 2023 AT THE NETCONG MUNICIPAL BUILDING, 23 MAPLE AVENUE, NETCONG, NEW JERSEY COMMENCING AT 7:30 PM.

The meeting was called to order by Mayor Nametko at 7:30 PM.

PLEDGE OF ALLEGIANCE

STATEMENT OF OPEN PUBLIC MEETINGS ACT

Those in attendance this evening were Councilman Albensi, Councilman Laureys, Councilman Morton, Councilman Still, and Mayor Nametko. Also present was Councilman Blakeslee, Borough Administrator and Mrs. Eckert, Borough Clerk

PUBLIC PORTION OF MEETING

Mrs. Nancy Esposito, 56 Koclas Dr., is here this evening to respectfully request that the borough remove the paintings on the newly paved road in front of her house. She would like them to come to her house to see how ugly it looks. It glows at night. It ruins the view of the lake. The mayor stated the state has mandated how the bike and walking trails need to be marked. Samantha Anello, Borough Engineer, provided details regarding the state mandates for this issue. Because it is state mandated and the project was done with grant funds, they cannot be removed. Councilman Laureys asked who she can contact to complain at the state level. Ms. Esposito stated there are too many in this small section of road. Ms. Anello confirmed that this is also state mandated.

Mr. Mark Richards, 58 Koclas Dr., has questions on the placing and size of the paintings on the ground. They are obtrusive. He would like to contact the DOT on this issue. He stated the road looks fantastic and is very smooth. He has a concern because there is a

dip in the pavement in front of his home. Samantha Anello, Borough Engineer, will be coming to his house next week to see it. He described the dip in front of his driveway and is concerned about ice buildup and safety. He is also concerned because the water from his sump pump ends up on the road. Ms. Anello stated if there is indeed a large dip, the contractor will be called back in to fix this issue.

Mr. Richards asked if curbing was replaced as well. In front of his house where the apron is, they just paved over it instead of fixing the concrete. He once again asked if the size of the paintings can be reduced. Ms. Anello will double check to make sure the size is correct. Mr. Richards thanked the Council for their time.

A Motion to close the meeting to the public was made by Councilman Albensi and seconded by Councilman Sylvester.

ENGINEER UPDATE: Well Status and Stormwater Management

Ms. Anello is here this evening to update the Council on the well status. She thanked the Council for their time. She explained that Netcong has many active projects going on. Many water systems in NJ are aging. Well 1A is not producing the yield it should. She went out to bid for an upgrade of this well. Mr. Blakeslee gave an update on the bid process for this. He originally went out for quotes as they are normally under the threshold. He decided to go out to bid since the quotes were so close to the threshold. He gave details on the two quotes we received. Our purchasing agent is suggesting we reject the current bids for the well rehab. Ms. Anello went on to explain a feasibility study done for this well to see if we can redrill or do a more permanent repair on this well so it does not have to be rehabbed every several years. The mayor stated in the next several years more rental units will be using the water from this well. Ms. Anello asked if the Council had any questions.

She moved on to the storm water regulation revisions. She provided details on the requirements that every municipality must meet and the new regulations that will need to be met. The state will be phasing in these requirements. She gave details on these new regulations. There is an action that the Council has to take which are two new ordinances which must be adopted by the end of the year. She said at this point they are in draft form. She provided additional details on these two new ordinances, the first being a private salt water storage ordinance. She said Netcong will probably have to police landscapers in town for compliance. The ordinance can be stricter than the state ordinance but cannot be less restrictive. Councilman Still asked if the state will be required to comply. Ms. Anello stated they will have to comply with the laws. The second ordinance which will require a lot more consideration for the Council. It will be for tree removal. Permits will be required for all tree removal. A resident will have to get a permit to remove any trees on their property. Again, the Council can make stricter rules but cannot do less than what is in the state ordinance. The size of the tree will determine if a permit is required. There will also be a replacement requirement. There will not be exemptions but there can be contributions in lieu of. She provided additional explanation on this issue. Mr. Blakeslee asked about street trees. Ms. Anello gave details on this issue as well. She gave detail on the draft ordinance and the certain things in it that can be changed and things that cannot. The fees and violations will be up to the municipality. Netcong will be audited on a yearly basis. Ms. Anello gave several benefits of this ordinance. Mr. Blakeslee asked who decides if a tree is diseased? Ms. Anello stated some towns require an arborist to certify the tree removal. Councilman Still asked if the borough can require someone to cut a tree if it is a danger. There was discussion among the Council on this issue. Ms. Anello stated the reason to bring this to the Council now is because the ordinance will happen so decisions should be discussed and made now. The Council thanked Samantha for her updates.
