PUBLIC PORTION OF MEETING

Mr. James Arbolino, 23 Allen St., complained for a year and a half about a building that is in disrepair. He stated nothing has been done. They are the Council in charge. Why has nothing changed? So much work has been done to improve the downtown. Now we have a building that is worse than any other town (he named several). He stated the owner stated he can't find a painter. Mr. Arbolino stated that is ridiculous. He wants to know why the Council has not done something about it. He provided suggestions on how to get this building improved. He continued stating the downtown should be the first place to make improvements. He has been here 84 years and has not seen something like this where a resident has been ignored. He wants to see something done.

Councilman Sylvester asked which building he was talking about. The response was the old fire house. The mayor stated he had to disagree on this. After he filed the complaint last year, a list was made and many issues were addressed. Mr. Arbolino stated he was on the Council for years. Councilman Still stated this will be taken care of immediately. Councilman Sylvester stated we developed this ordinance to take care of these issues. Mr. Arbolino thanked the Council for their time. Mr. Blakeslee will deliver the message personally tomorrow. The mayor suggested we ask to have curtains put in the windows to hide the clutter. Councilman Still suggested red tagging the whole building.

Councilman Sylvester stated he did fix the issues on the inside of the building. He is not sure if the building can be red tagged at this time. There was further discussion among the Council on this issue. Mr. Blakeslee made several comments on this subject as well.
