The meeting was called to order by Mayor Nametko at 7:30 PM.

Mr. Blakeslee noted that those commercial businesses that paid for their own dumpster would not be charged. She also had a question about the stickers, large items and spring cleaning. Mr. Blakeslee and the Mayor responded. Councilman Laureys offered a suggestion for the large items.

Mr. Mathew Eddy, 25 Flanders Road, asked if he could plant bushes in the recycle area, just to spruce it up. The mayor stated he could speak with Mike Canfield. Mr. Eddy also had a question about the old tool factory. Mr. Blakeslee responded.
