PRIVILEGE OF THE FLOOR TO THE COUNCIL

Council President Still stated a great job was done by all at the food truck festival including all employees.

Councilman Laureys has two issues he would like to discuss. First, he wanted to address the letter from Mr. Fredericks, president of the NCP. He reviewed the comments in the letter and gave his opinions regarding this. His concern is if the farmers market is bringing business to our businesses in town. Councilman Laureys suggested that a member of the NCP be present at a station in the front of the market to ask guests what town they are from. This would be a way to determine how the mailers are doing.

Councilman Laureys also had comments regarding the NCP and how some members wanted to disband about ten years ago. He feels this forced membership is unfair to businesses. He gave details on his concerns about this organization and his objections to it. Mr. Pisano, a member of the NCP stated from the audience there are no surveys planned at this time. Councilman Laureys is against the ordinance that was just passed to include additional multifamily properties. He did his own survey and noted that the majority of the people he spoke with did not want the NCP. He added that there was some questioning of his survey's validity. He added more reasons why he is against this

organization. There was discussion among the Mayor and Councilman Laureys on his comments regarding the spending of NCP funding.

Councilman Laureys also had an issue with the high-density housing units. He addressed the Council members who have lived here for many years. He stated "Do we want this town to become like Parsippany or do we want to keep Netcong the small town we grew up with". He gave further comments about the statistics about prospective numbers of students that will be added to the school. Councilman Still stated he is beginning to bully members of the Council. The mayor asked how many apartments there are in Netcong Heights. Councilman Laureys started giving statistics. Councilman Hathaway gave his opinion on this situation. The mayor asked Councilman Laureys to finish his statement. Councilman Laureys ended by asking 'what the objection is to putting single-family homes as opposed to high density homes.' Councilman Albensi gave his opinion and stated what he felt were the actual statistics on how many students are going to the school from the high-density units. He stated out of the 550 high density units, there are 18 students in the elementary school. The rest of the 300 children are from single family homes. The mayor stated that the point was made and we need to move forward.

Councilman Sylvester asked if there can be comments on resolutions later. He received feedback from Councilman Hathaway and the Mayor.

Mayor Comments

Mayor Nametko was concerned that Councilman Laureys called some members of the NCP socialists and they took offense to it. Mr. Laureys then stated he did not call them that, but that this is a socialist type program.
