MINUTES OF THE MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF NETCONG HELD NOVEMBER 2, 2023 AT THE NETCONG MUNICIPAL BUILDING, 23 MAPLE AVENUE, NETCONG, NEW JERSEY COMMENCING AT 7:30 PM.

The meeting was called to order by Mayor Nametko at 7:30 PM.

PUBLIC PORTION OF MEETING

Mrs. Maryanne Engelhart, Amendola Dr., wanted to know why the taxes are so high. The Council explained to her that it is coming from the school. The school taxes went up 10%, the municipal tax went up 2%. She stated she heard they are funding schooling for illegals. The mayor stated she would need to go to the board of ed for answers to that question. She is also concerned about the winter parking. She has too many cars to fit in her parking lot. She is also concerned about the paving on Amendola Dr. and why it is not being done. The mayor explained the cost of paving her street is approximately \$400,000.00. Councilman Hathaway explained to her why the pipes need to be put in the ground before paving is done or the borough will not receive grant money. He explained grants would be applied for in this grant season for her street. She also asked about the new apartments and the taxes that they are not paying. The mayor explained the low-income housing process in the new apartment complex. Councilman Hathaway explained how the process for COAH works and that this is coming from the state. It was determined there are a total of 20 assisted units within the 2

new apartment complexes. Councilman Still stated she should not be discussing illegal citizens at a public forum. Councilman Hathaway stated it is a crime to discriminate. The town does not have those types of controls. The mayor thanked her for her time.
