**WHEREAS**, the Borough of Netcong has a need to obtain the services of a Traffic Engineer and has determined to award the contract as a professional service without obtaining competitive bids or quotations pursuant to the provisions of N.J.S.A. 19:44A-20.5; and

WHEREAS, the Borough has determined and certified in writing that the value of the service will exceed \$17,500.00; and

WHEREAS, the anticipated term of this contract is one year; and

WHEREAS, Joseph A. Fishinger, P.E., P.P., P.T.O.E. has submitted a proposal indicating that he will provide the services of Borough Engineer at an hourly rate of \$180.00 per hour for services rendered; and

WHEREAS, Joseph A. Fishinger, P.E., P.P., P.T.O.E. has completed and submitted a Business Entity Disclosure Certification which certifies that he has not made any reportable contributions to a political or candidate committee in the Borough of Netcong for the previous one year, and that the contract will prohibit him from making any reportable contributions through the term of the contract; and
