Mrs. Dolan and Mr. Gabloff stepped forward to give details:

Mrs. Dolan provided details on the budget. Much work went into this budget. The budget is very fiscally sound. She gave details that there is a small tax decrease due to the establishment of the solid waste budget and implementation of the PILOT for 34 Bank.

Mr. Gabloff stated there was a concern with staying in line with the inflation. There was a lot of work to work this budget. There was also a great effort to clean up the debt paydown. The mayor thanked the finance committee for all their hard work. Councilman Sylvester stated it is nice to hear that this budget is so good and there is no public to hear it. Councilman Nametko stated he is concerned about those who do not understand the PILOT program and the positive effect it has on the budget. Mrs. Dolan explained if the new PILOTS begin next year, it should improve the cap bank. The Mayor and Council thanked them for their time.

ANNUAL AUDIT

Mrs. Dolan gave several highlights and details on the audit. The Tax Collection rate is 98.50%. She explained the debts and how they will be paid down. There is one comment in the audit which is segregation of duties which will not change because of the size of the municipality. Details were provided regarding the grant money that needs to be spent down. There is a new standard with compensated absences. The auditors did additional testing on this and did not find any problems in this area. Councilman Nametko asked if we will have a state review next year. Mrs. Dolan said yes. The mayor thanked Mr. Blakeslee for his work as well.

The Mayor and Council thanked him for his service.

BOROUGH ADMINISTRATOR REPORT

Mr. Blakeslee reminded the Council to Complete the risk management webinar before the end of the month.

He then explained the details from The NJ Transit letter received. The residents on Stoll St. requested they be allowed to park on this property as they have no parking on their site. Councilman Sylvester stated NJ Transit wants the town to take over this property and clean it up. They do not want to clean it themselves. Councilman Hathaway stated this was discussed in the public works committee meeting. This will only benefit a small group of people in town which is not the best use of funds. He is concerned. He does not want to take on this responsibility. There was discussion among the Council on these parking issues. Councilman Hathaway feels the property owners need to solve their issues; it should not be the taxpayers' responsibility. Councilman Nametko stated this becomes a liability as well. There was further discussion on this issue and in other areas of the town as well. Mr. Canfield, DPW superintendent, was asked questions about the Arbolino Park areas. NJ Transit will have to do this. The Council will send a letter denying the town's responsibility for this issue.

Mr. Blakeslee would like approval for a traffic study to be done for the Roxbury McNear warehouse project. It will be facilitated through the Old Traveled Way. There was further discussion on this subject. The Council gave him approval to move forward.

COMMITTEE REPORTS

Finance & Insurance: J. Nametko J. Sylvester
Councilman Nametko read his report.

For the month of April 2024, the Borough had a total income of \$665,681.16 as compared to \$713,538.48 in 2023.

For the month of April 2024:

Miscellaneous Revenue Not Anticipated (MRNA):

In 2024 the Borough received \$9,738.68 compared to \$960.50 in 2023.

This includes \$5,138.13 collected by the Planning Board in Application fees.

Other Licenses/Borough Clerk's Fees:

The Borough received \$36,997.21 in 2024 compared to \$31,208.19 in 2023.

State Aid:

There was no state aid received in 2024 however we received \$15,000 in 2023.

Grants in Aid:

There was \$3,529.18 received in 2024 for Grants in Aid and \$4,263.04 was received in 2023.

Taxes Collected:

The Borough collected \$543,265.03 in 2024 compared to \$616,164.04 in 2023.

Water and Sewer Utility:

The Borough collected \$40,085.88 in 2024 compared to \$45,532.71 in 2023.

Solid Waste Utility:

There was \$32,065.18 collected this past month.

Economic Development: R. Hathaway J. Nametko

Councilman Hathaway noted that regarding 83 Main St, there will be a meeting with the owners on May 30th and he has asked a planning board member to attend. There has

been discussion on trading parking for an easement for the current business owners. He is hoping to see a site plan for this.

Rock Solid: Councilman Hathaway stated that they are near a deal brokered with the redevelopment agreement and financial agreement, which will be different from the PILOT. They have asked to go to the planning board concurrent with their meeting with the EDC. He gave details on the redevelopment agreement. The Board will ask for a contribution to the Main St. improvements. The area of rehabilitation is a 5-year plan. He discussed aspects of the financial agreement. They must pay the current taxes during the development of the project. He gave further detail on the financial agreement years 1-5. Schools will still get their fair share of taxes. During construction full taxes will be collected. Councilman Nametko stated the committee was determined to make sure the school will not be affected. Councilman Hathaway gave more detail on the financial agreement.

Parking/Park/Pedestrian Plaza on Bank St. is still being worked on by Mr. Blakeslee to get state money to purchase the land and develop it. The deadline for the application is mid-June. Mr. Blakeslee has been collecting letters of support for this project to submit with the grant application. Councilman Hathaway is hoping this will be a segway to future projects for the downtown. Mr. Blakeslee stated we have a DOT grant application for the Bank St. area to widen the sidewalks and pave the road.

Councilman Laureys asked when the sidewalks on Jenny Lind St. will be installed. The response was that bids will probably be done in July.

Mayor Still also wanted to discuss if there is sewage flow from Roxbury. The sump pumps put into the sewer drains is going to be a problem. The mayor is concerned that our MSA rates are going to go up. The mayor would like an INI study. There was discussion among the Council on this issue of sump pumps' output into the sewer drains.

Councilman Sylvester asked: Will the traffic study include pedestrian traffic? Mr. Blakeslee said he believes it should be. Councilman Hathaway asked about the park and trail professionals. Mr. Blakeslee said it is in the works. Councilman Sylvester said he is working on an in-person meeting for the Lake project. Mr. Conrads is working on this meeting. There was discussion on this subject among the Council.

Councilman Nametko mentioned there is a lawn service that is applying something on the lawns in his neighborhood. He noted a bad garbage-like smell in his backyard for days. He would like some kind of control for this type of situation. Councilman Hathaway stated all these operations are controlled by the state and are highly regulated. Councilman Hathaway stated local health departments can investigate. Mr. Blakeslee will get the name of the company so he can investigate. The mayor asked if there is an ordinance we can write for this. There was further discussion on this subject.

Councilman Laureys reported that he took a walk and talked to a resident on Wiltop Rd. who is not in favor of the St. Michaels development. The mailman let him know there are many residents that are not in favor.

RESOLUTION FOR SELF-EXAMINATION OF 2024 BUDGET

WHEREAS, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and

WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997; and

WHEREAS, pursuant to N.J.A.C. 5:30-7.2 through 7.5, the *Borough of Netcong* has been declared eligible to participate in the program by the Division of Local government Services, and the Chief Financial officer has determined that the local government meets the necessary conditions to participate in the program for the 2021 budget year.

NOW THEREFORE BE IT RESOLVED by the governing body of the *Borough of Netcong* that in accordance with N.J.A.C. 5:30-7.6a & 7.6b and based upon the Chief Financial Officer's certification, the governing body has found the budget has met the following requirements:

1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:
 - a. Payment of interest and debt redemption charges
 - b. Deferred charges and statutory expenditures
 - c. Cash deficit of preceding year
 - d. Reserve for uncollected taxes
 - e. Other reserves and non-disbursement items
 - f. Any inclusions of amounts required for school purposes.
2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at N.J.S.A. 40A:4-45.3 et seq., are fully met (complies with CAP law).
3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
4. That pursuant to the Local Budget Law:
 - a. All estimates of revenue are reasonable, accurate and correctly stated,
 - b. Items of appropriation are properly set forth
 - c. In itemization, form, arrangement and content, the budget will

permit the exercise of the comptroller function within the municipality.

5. The budget and associated amendments have been introduced and publicly advertised in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.

6. That all other applicable statutory requirements have been fulfilled.

BE IT FURTHER RESOLVED that a copy of this resolution will be forwarded to the Director of the Division of Local Government Services upon adoption.

Finding # 2023-1

Description: Segregation of duties in Treasury functions.

Analysis: Borough does not have optimum separation of duties between persons dispersing funds and reconciling bank accounts, and between collecting and recording funds.

Capital Ordinance 2024-15

It is hereby determined and stated that the Supplemental Debt Statement required by the Local Bond Law has been duly made and filed in the office of the Borough Clerk of said Borough, and that such statement so filed shows that the gross debt of said Borough, as defined in Section 43 of the Local Bond Law, is increased by this ordinance by \$748,000 and that the issuance of the bonds and notes authorized by this ordinance will be within all debt limitations prescribed by said Local Bond Law.

It is anticipated that a grant in the amount of \$286,693 from the New Jersey Department of Transportation shall be received by the Borough to finance the cost of the improvement described in Section 1 hereof. Said grant funds shall be applied as set forth in Section 9 hereof. Said improvement shall be made as a general improvement and no part of the cost thereof shall be assessed against property specially benefited.

Section 3. It is hereby determined and stated that (1) said purpose is not a current expense of the Borough, and (2) it is necessary to finance said purpose by the issuance of obligations of the Borough pursuant to the Local Bond Law, and (3) the estimated cost of said purpose is \$325,000, and (4) the estimated maximum amount of bonds or notes necessary to be

issued for said purpose is \$325,000, and (5) the cost of said purpose, as hereinbefore stated, includes the aggregate amount of \$50,000, which is estimated to be necessary to finance the cost of said purpose, including architect's fees, accounting, engineering and inspection costs, legal expenses and other expenses, including interest on such obligations to the extent permitted by Section 20 of the Local Bond Law.

Section 4. To finance said purpose, bonds of the Borough of an aggregate principal amount not exceeding \$325,000 are hereby authorized to be issued pursuant to the Local Bond Law. Said bonds shall bear interest at a rate per annum as may be hereafter determined within the limitations prescribed by law. All matters with respect to said bonds not determined by this ordinance shall be determined by resolutions to be hereafter adopted.

Section 5. To finance said purpose, bond anticipation notes of the Borough of an aggregate principal amount not exceeding \$325,000 are hereby authorized to be issued pursuant to the Local Bond Law in anticipation of the issuance of said bonds. In the event that bonds are issued pursuant to this ordinance, the aggregate amount of notes hereby authorized to be issued shall be reduced by an amount equal to the principal amount of the bonds so issued. If the aggregate amount of

outstanding bonds and notes issued pursuant to this ordinance shall at any time exceed the sum first mentioned in this section, the moneys raised by the issuance of said bonds shall, to not less than the amount of such excess, be applied to the payment of such notes then outstanding.

Section 6. Each bond anticipation note issued pursuant to this ordinance shall be dated on or about the date of its issuance, shall be payable not more than one year from its date, shall bear interest at a rate per annum as may be hereafter determined within the limitations prescribed by law and may be renewed from time to time pursuant to and within limitations prescribed by the Local Bond Law. Each of said notes shall be signed by the Mayor and by a financial officer and shall be under the seal of the Borough and attested by the Borough Clerk or Deputy Borough Clerk. Said officers are hereby authorized to execute said notes and to issue said notes in such form as they may adopt in conformity with law. The power to determine any matters with respect to said notes not determined by this ordinance, and also the power to sell said notes, is hereby delegated to the Chief Financial Officer who is hereby authorized to sell said notes either at one time or from time to time in the manner provided by law.

Section 7. It is hereby determined and declared that the period of usefulness of said purpose, according to its reasonable life, is a period of ten years computed from the date of said bonds.

Section 8. It is hereby determined and stated that the Supplemental Debt Statement required by the Local Bond Law has been duly made and filed in the office of the Borough Clerk of the Borough, and that such statement so filed shows that the gross debt of the Borough, as defined in Section 43 of the Local Bond Law, is increased by this ordinance by \$325,000 and that the issuance of the bonds and notes authorized by this ordinance will be within all debt limitations prescribed by the Local Bond Law.

Section 9. Any funds received from private parties, the County of Morris, the State of New Jersey or any of their agencies or any funds received from the United States of America or any of its agencies in aid of said purpose shall be applied to the payment of the cost of said purpose or, if bond anticipation notes have been issued, to the payment of the bond anticipation notes, and the amount of bonds authorized for said purpose shall be reduced accordingly.

Section 10. The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of

any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Borough Clerk and is available for public inspection.

Section 11. The Borough intends to issue bonds or notes to finance the cost of the improvement described in Section 1 of this bond ordinance. If the Borough incurs such costs prior to the issuance of such bonds or notes, the Borough hereby states its reasonable expectation to reimburse itself for such expenditures with the proceeds of such bonds or notes in the maximum principal amount of bonds or notes authorized by this bond ordinance.


Section 12. The full faith and credit of the Borough are hereby pledged to the punctual payment of the principal of and interest on the obligations authorized by this ordinance. Said obligations shall be direct, unlimited and general obligations of the Borough, and the Borough shall levy ad valorem taxes upon all the taxable real property within the Borough for the payment of the principal of and interest on such bonds and notes, without limitation as to rate or amount.

Section 13. This ordinance shall take effect twenty days after the first publication thereof after final passage.
