MAYORS' COMMENTS

The mayor had no comments at this time.

PUBLIC PORTION OF MEETING

Mr. JW Albensi, 42 College Rd., discussed no parking to Water St. (the parking just discussed) may be an issue for the concerts in the park at night. An exception may have to be made for this. Councilman Hathaway and Mr. Albensi had discussed putting a larger concrete pad in front of the gazebo for dancing and other group activities. This will also make better handicap access by the gazebo. Mr. Blakeslee stated the grant for the park got turned down due to minor deficiencies in the application but the borough has been invited to reapply for this year. This was the dept. of senior services grant application with the state. Mr. Albensi wants to be sure these improvements are not done during the concert season. The mayor stated the engineer will be going down there to assess.

Mrs. Michele Franchi Ruocco, 39 Main St., asked if it is possible to prohibit overnight parking on Main St. She gave her reasons for asking about this. Tenants that live on Main St. tend to park overnight. The council suggested having 2- hour parking all the time, not just during the day. There was discussion among the council on this. Councilman Hathaway stated in the past it was decided to include this in the traffic study for Main St by the Highlands Council. The council does not want to install meters. Mrs. Ruocco suggested parking meters would help to resolve this issue. Councilman Sylvester stated it is hard to enforce the 2-hour parking limit. Councilman Laureys said meters might cause businesses to lose business. The mayor stated we will address this again. Mrs. Ruocco thanked the council for their time.

Mrs. Kim Albensi, 42 College Rd., felt the community fair was successful. She thanked Councilman Nametko and Councilman Sylvester for their contribution. The groups that attended did reap some volunteers.
