The resignation was accepted by the Council. The Mayor had several comments. He stated committee issues should be taken care of by each committee chair. Councilman Nametko stated motions should be made by the committee chair at meetings. Councilman Hathaway asked who Mr. Skillen reports to. The Mayor stated he would report to the Mayor. The Mayor has cancelled the municipal alliance for this year. If we can find a new person to chair it, we will reinstate it. There was brief discussion on this subject among the Council. The Mayor thanked Mr. Skillen for the work that he did before his resignation.

- 5. **New Business-** 2025 Municipal Budget

The Mayor asked Ralph Blakeslee, Administrator, to speak on this subject. Councilman Nametko, Finance Chair, provided several comments on this budget and some changes that will be made in October for next year's budget. They will try to implement a 3-year capital plan. He stated we have kept our fund balance steady and debt is continued to be paid down. He thanked the finance committee for their great job. He feels this is a good budget. The CFO and Auditor will be here next week to speak on the 2025 budget. Mr. Blakeslee went on to explain the process. Councilman Nametko asked to review the bond and capital ordinances before they are given to the full Council. It was also suggested older capital funds be closed out and put into the capital fund. Councilman Nametko stated we have stayed in the cap despite a decrease of \$600,000 NVT. Mr. Blakeslee stated some of the decreases are due to demolition of several buildings and fire damage which will be replaced going forward with new buildings. He stated the 100% disabled vets are dipping into our NVT. We need to discuss with our legislators to have reimbursement for these properties.

Councilman Laureys would like to get numbers on what the SID has spent their money on. Councilman Hathaway stated Councilman Laureys is welcome to come to any SID meeting to see how they operate. Councilman Hathaway had further comments on this issue.

Councilman Eddy attended the NEF St Patty's event with his wife. It was excellent. Councilman Hathaway stated it was a very successful event. Councilman Sylvester reported that there will be Fish and Chips next Friday.

A RESOLUTION AUTHORIZING A SHARED SERVICES
AGREEMENT WITH THE TOWNSHIP OF ROXBURY FOR THE
FURNISHING OF STREET SWEEPING AND JET VACUUM SERVICES
IN ACCORDANCE WITH THE UNIFORM SHARED SERVICES AND
CONSOLIDATION ACT, N.J.S.A. 40A:65-1, ET SEQ. FOR A TERM OF FOUR YEARS
COMMENCING APRIL 3, 2025 AND TERMINATING DECEMBER 31, 2029

WHEREAS, the Township of Roxbury has agreed to provide street sweeping and jet vacuum truck services to the Borough of Netcong for a term of five (5) years beginning April 3, 2025 and terminating December 31, 2029; and

WHEREAS, the Borough Council of the Borough of Netcong finds that it is in the public interest to enter into a shared services agreement with the Township of Roxbury, in the form attached hereto for the provision of said services in accordance with the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1, et seq.; and

WHEREAS, the Borough's Chief Financial Officer has certified that funds are available for this purpose.

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Netcong, in the County of Morris and State of New Jersey, as follows:

- 1. A Shared Services Agreement with the Township of Roxbury for street sweeping and jet vacuum services. Said Agreement is for a term of five (5) years and is on file in the Office of the Borough Clerk and may be inspected by the public during normal business hours.
- 2. The Mayor and Borough Clerk are hereby authorized and directed to execute said Shared Services Agreement on behalf of the Borough.
- 3. A copy of the fully executed Agreement as well as the Resolution authorizing same shall be provided to the Department of Community Affairs ("DCA") in accordance with

N.J.S.A. 5:23-4.6(b)1. The Borough Clerk is hereby authorized and directed to coordinate with the Roxbury Township Clerk the filing of said documents with DCA.

- 4. The Borough Clerk is further authorized and directed to provide a copy of the fully executed Agreement to the Morris County Joint Insurance Fund for its file.
 - 5. This Resolution shall take effect immediately.
