MINUTES OF THE MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF NETCONG HELD APRIL 10, 2025 AT THE NETCONG MUNICIPAL BUILDING, 23 MAPLE AVENUE, NETCONG, NEW JERSEY COMMENCING AT 7:30 PM.

The meeting was called to order by Mayor Still at 7:30 PM.

PLEDGE OF ALLEGIANCE

INTRODUCTION OF THE 2025 MUNICIPAL BUDGET

The mayor thanked all involved in the budget process for their efforts. Mr. Gabloff stepped forward to give a brief synopsis on the budget. He spoke about the tax increase for this year with no reduction of services and a good capital plan.

This year is a self- review, which includes a checklist. We are under both the levy and appropriations cap. He stated the PILOT income helped keep in the cap. Fund balance is in good shape the same as the last several years. Councilman Hathaway stated we are actually providing additional services. He thanked the finance committee for a great job. Councilman Nametko commented about the \$16,000 fund balance. He would like to see any MRNA funds be added to the fund balance or pay down more debt instead of spending the funds. Councilman Laureys asked have we ever dipped into our cap bank money. Mr. Gabloff stated it has not been dipped into since around 2008-2010. Councilman Nametko had several comments on this topic. Councilman Laureys asked about the cap money process. Mr. Gabloff discussed the process. The mayor thanked Mr. Gabloff for his time.

He gave his opinion on SID advertising and its effectiveness as well. He feels the Council should no longer give a contribution to the SID.

For the month of March 2025, the Borough had a total income of \$1,267,233.44 as compared to \$461,171.44 in 2024.

Miscellaneous Revenue Not Anticipated (MRNA):

In 2025 the Borough received \$3,198.50 compared to \$20,094.92 in 2024.

In 2024 we received Construction Fees from Byram and to date we have not this year.

Other Licenses/Borough Clerk's Fees:

The Borough received \$27,190.03 in 2025 compared to \$37,901.12 in 2024.

Interest rates have dropped so this is the cause of this deficiency.

State Aid:

Nothing was received in 2025 or 2024.

Grants in Aid:

We received \$730,082.60 in 2025 and \$6,137.37 in 2024 for Grants in Aid.

Taxes Collected:

The Borough collected \$144,219.31 in 2025 compared to \$35,146.72 in 2024.

Water and Sewer Utility:

The Borough collected \$349,482.78 in 2025 compared to \$341,746.04 in 2024.

Solid Waste Utility:

The Borough collected \$13,060.22 in 2025 compared to \$20,145.27 in 2024.

The Morris County Grant has been submitted for the Trail Project. Final deadline to approve is in June 6th.

There was a meeting with Roxbury Township on April 17th to discuss Arbolino Park expansion.

Mr. Blakeslee stated Rock Solid (Koch Property) is filing for demolition permits at this time. Hopefully there will be activity there by June.

Councilman Nametko stated the work of Councilman Sylvester, Councilman Hathaway and Mr. Bucco was what gave us the opportunity for the Trail Grant.

The Council President had nothing to report at this time.

Councilman Morton wanted to mention that the police department was also at the task force meeting. He added that Mr. Hess and his men are installing the new fencing at Arbolino Park. He thanked them for their work.

Councilman Laureys was hoping the SID will do a survey of its members soon.

Councilman Hathaway started with a statement "What do you think the result would be if we census the community as to whether they wanted to pay taxes?" He noted that there was a long-standing relationship at this Dais. He went on to further explain that the committee leaders are here on this dais for a reason. He is concerned that Councilman Laureys is overstepping as the SID is not part of his committee. Opinions, back points, and quantification are welcome at this dais. These should be presented at the SID meetings or to the Council Chair of that committee. They are not appropriate at a recorded Public Council Meeting and he objects to them. Councilman Hathaway ended with "I hope that we can conduct ourselves with better decorum in the future." There was continued discussion among the Council.

Councilman Nametko stated when the Council provides funds to the SID it is not only for decorations as Councilman Laureys stated. He then provided examples of expenditures to enhance Netcong.

CALENDAR YEAR 2025 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Mayor and Council of the Borough of Netcong in the County of Morris, finds it advisable and necessary to increase its CY 2025 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Mayor and Council of the Borough of Netcong hereby determines that a 1% increase in the budget for said year, amounting to \$40,473.35 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Mayor and Council of the Borough of Netcong hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Mayor and Council of the Borough of Netcong in the County of Morris, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2025 budget year, the final appropriations of the Borough of Netcong shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5 %, amounting to \$141,656.73 and that the CY 2025 municipal budget for the Borough of Netcong be approved and Adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

2025 COST ESTIMATE FOR NETCONG SPECIAL IMPROVEMENT DISTRICT

It is estimated that the Special Improvement district will expend \$46,525 in the year 2025. The categories in which money will be spent are expected to be:

- 1. Business Promotions, Retention, Attraction
- 2. Community Engagement
- 3. Operations and Beautification
- 4. Special Events/Netcong Day*
- 5. Administration, Professional Services

The revenue to cover these expenses is scheduled to come from the following sources:

A RESOLUTION AUTHORIZING THE AWARD OF A CONTRACT TO PACIFIC CONSTRUCTION, LLC FOR THE LEAD SERVICE LINE REPLACEMENT PROJECT IN THE BOROUGH OF NETCONG, MORRIS COUNTY, NEW JERSEY

WHEREAS, the Borough of Netcong solicited bids for the Lead Service Line Replacement Project in the Borough; and

WHEREAS, the Borough Clerk, on March 20, 2025, received seven (7) bids for the above-referenced project; and

WHEREAS, Pacific Construction, LLC submitted the lowest responsible and responsive bid pursuant to the Borough's specifications for the above-referenced contract; and

WHEREAS, the Borough Engineer and Borough Attorney have reviewed the bids and have found that the bid submitted by Pacific Construction, LLC is in proper form and may be awarded by the Borough Council; and

WHEREAS, the Borough Council wishes to award the contract to Pacific Construction, LLC in accordance with its base bid, plus supplemental bid "A", in the amount of \$588,723.00; and

WHEREAS, the Chief Financial Officer of the Borough of Netcong has certified that funds are available for this purpose.

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Netcong, in the County of Morris and State of New Jersey, as follows:

1. A contract for the Lead Service Line Replacement Project is hereby awarded to Pacific Construction, LLC, 350 Montgomery Street, Passaic, New Jersey, 07055, in accordance with its base bid proposal, plus supplemental bid "A", in the amount not to exceed \$588,723.00.
