MINUTES OF THE MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF NETCONG HELD MAY 8, 2025 AT THE NETCONG MUNICIPAL BUILDING, 23 MAPLE AVENUE, NETCONG, NEW JERSEY COMMENCING AT 7:30 PM.

The meeting was called to order by Mayor Still at 7:30 PM.

PLEDGE OF ALLEGIANCE

STATEMENT OF OPEN PUBLIC MEETINGS ACT

The Borough Clerk read the following statement: Adequate notice of this meeting as defined by the Open Public Meetings Act has been provided by:

ROLL CALL

Those in attendance this evening were Councilman Eddy, Councilman Hathaway, Councilman Laureys, Councilman Morton, Councilman Nametko, Councilman Sylvester and Mayor Still. Also present was Mrs. Eckert, Borough Clerk and Mr. Blakeslee, Borough Administrator.

APPROVAL OF MINUTES

None presented.

NETCONG BOARD OF EDUCATION TO ADDRESS THE COUNCIL

Netcong School Budget

Mrs. Kathleen Walsh, Superintendent and Mr. Paul Stabile, Business Administrator stepped forward to present their budget. Mrs. Walsh began by reviewing accomplishments for 2024-2025 which included capital projects and programs for the students. She continued with the budget goals for the 2025-2026 school year, which include capital and student programs. She then provided the statistics on the student enrollment and gave information on the state increasing costs.

Mr. Stabile stepped forward to explain the state aid numbers. He reported how the state formula works and how the state establishes the amount of aid that the district is eligible for and the reason for the 15% increase in the tax levy. He explained the issue arises because the state aid has been cut this year. Mrs. Walsh stated they will apply for extraordinary aid but there are no guarantees that they will receive it. She explained special education costs are increasing for the following year. Mrs. Walsh explained the current shared services with other entities. Mr. Stabile provided the numbers comparing the current year to next year. He stated the debt service is continuing to decrease. He stated there is no capital budget for next year. There are several capital projects to be completed with the funds from this year's budget. He then reviewed the tax impact. Mr. Stabile provided a detailed comparison of the tax levy from 1995 to current. Mrs. Walsh summarized the presentation.

The mayor asked if anyone in the audience had questions for the board. Mr. Rick Sylvester, Allen St. wanted to know if there was a study for regionalizing the districts. Mrs. Walsh stated the application was submitted but they are waiting on the approval of the grant to do the study. He asked if there would be an influx of funds for this year for attendance. Mr. Stabile stated 'no.' The Mayor asked if the council had questions. Councilman Laureys had a question about sending students out of the district. Mr. Stabile noted the cost to the district. He stated 100,000.00 for one of the students, 90,000.00 for another which does not include travel. 1.2 million will be needed to send special needs students out of the district for 10 children. Councilman Sylvester asked when this would end. Mrs. Walsh did not have an answer. Councilman Sylvester stated the taxpayers cannot continue to bear these increases. Mrs. Walsh is aware of this situation. She realizes this is problematic. Mr. Stabile gave detail on the problems with the state aid. He stated the state needs to decide how to correct the state aid program. He wished there was a better explanation on the state formula. Councilman Hathaway stated we realize the only solution to this is regionalization. He wants to know how the council and residents can move this forward. The study for regionalization could take 9 months to a year. The earliest to vote on the regionalization could take as long as 2-3 years after the study. Councilman Nametko asked if there is a cost study on regionalization. Councilman Hathaway asked if the other districts are having the same issues. Mr. Stabile stated they are worse than Netcong. They gave further issues with this issue. Mrs. Walsh gave examples of other towns that have had to close schools and cut positions. Councilman Sylvester asked why there is a 15% increase. Mrs. Walsh explained because of student enrollment.

Mrs. Walsh introduced the school architect who is here to discuss the referendum. Frank Messineo, architect for the school since 2021, discussed the possible ways to improve the school. He stated there are capacity limitations. He gave detail on the referendum for 2026. The original section of the building is 99 years old. State aid is available when the project is funded through a referendum. He explained the process for this referendum which began in 2021. He added the details year by year. He continued with the timeline for the referendum. He gave the capital components as well as the educational components. He provided a floor plan showing the improvements and changes. There were also renderings of the possibilities for the modular unit and interior changes. He then

provided the projected costs of the educational project: \$7,400,000.00. Total cost with fees and 10% contingency: \$9,000,000.00. \$2,000,000: debt service, \$7,000,000.00 to taxpayers. Tax impact would be \$420.00 per year for the average home in Netcong. The district will have an assessment calculator on their website to see what the average annual impact is for residents to use. He then gave the effects of doing nothing. No detailed designs will be done until the referendum passes. This presentation will be available on the school website for residents to view. He continued with facts and answers to common questions.

Mr. Rick Sylvester asked what the projected number increase is for this expansion. Mr. Messineo stated it is based on the current enrollment. He expanded on this subject. Councilman Sylvester wanted to know why this is not being put on pause until the regionalization is done. Councilman Sylvester asked if this can be done without being all in. Mr. Messineo responded. He stated the district is not putting these requirements on, they are coming from the DOE. There was discussion among class size numbers. Mr. Blakeslee had one comment about the online assessment. It should be stated it is the assessed value.

Mrs. Lea Behmer, was concerned about how much money was needed from the taxpayers and how does this work and where is all the money going? The Mayor provided a general explanation of the larger portions of the budget.

Mrs. Kate Trackim, Kings Rd., asked what the life of the modular improvements are. Mr. Messino stated it was 20 years.

This comment has already been corrected. One suggestion to management is to be mindful of federal funds that could be audited in the future.

Councilman Nametko thanked the mayor and finance committee for their work on the budget. He hopes the taxpayers understand the PILOTS have helped our budget. The school does not lose money from the PILOTS; they are fully funded. He provided detail on the debt and thanked the council for their diligence. We went to a groundbreaking this week, that project should bring more revenue when it is complete.

The mayor thanked the finance committee and those involved in preparing the budget.

For the month of April 2025, the Borough had a total income of \$583,083.90 as compared to \$665,681.16 in 2024.

For the month of April 2025:

Miscellaneous Revenue Not Anticipated (MRNA):

In 2025 the Borough received \$8,776.25 compared to \$9,738.68 in 2024.

Other Licenses/Borough Clerk's Fees:

The Borough received \$24,418.58 in 2025 compared to \$36,997.21in 2024.

Interest rates have dropped so this is the cause of this deficiency.

State Aid:

Nothing was received in 2025 or 2024.

Grants in Aid:

We received nothing in 2025 and \$3,529.18 in 2024 for Grants in Aid.

Taxes Collected:

The Borough collected \$465,816.68 in 2025 compared to \$543,265.03 in 2024.

Water and Sewer Utility:

The Borough collected \$53,515.11 in 2025 compared to \$40,085.88 in 2024.

Solid Waste Utility:

The Borough collected \$30,557.28 in 2025 compared to \$32,065.18 in 2024.

Ordinance 2025-3

CALENDAR YEAR 2025 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Mayor and Council of the Borough of Netcong in the County of Morris, finds it advisable and necessary to increase its CY 2025 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Mayor and Council of the Borough of Netcong hereby determines that a 1% increase in the budget for said year, amounting to \$40,473.35 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Mayor and Council of the Borough of Netcong hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Mayor and Council of the Borough of Netcong in the County of Morris, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2025 budget year, the final appropriations of the Borough of Netcong shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5 %, amounting to \$141,656.73 and that the CY 2025 municipal budget for the Borough of Netcong be approved and Adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BOND ORDINANCE TO AUTHORIZE THE MAKING OF VARIOUS PUBLIC IMPROVEMENTS AND THE ACQUISITION OF NEW ADDITIONAL OR REPLACEMENT EQUIPMENT AND MACHINERY IN, BY AND FOR THE BOROUGH OF NETCONG, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, TO APPROPRIATE THE SUM OF \$365,500 TO PAY THE COST THEREOF, TO APPROPRIATE A STATE GRANT, TO MAKE A DOWN PAYMENT, TO AUTHORIZE THE ISSUANCE OF BONDS TO FINANCE SUCH APPROPRIATION AND TO PROVIDE FOR THE ISSUANCE OF BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE OF SUCH BONDS.

BE IT ORDAINED by the Borough Council of the Borough of Netcong, in the County of Morris, State of New Jersey, as follows:

Section 1. The Borough of Netcong, in the County of Morris, State of New Jersey (the "Borough") is hereby authorized to make various public improvements and to acquire new additional or replacement equipment and machinery in, by and for said Borough, as more particularly described in Section 4 hereof. The cost of the improvements includes all work, materials and appurtenances necessary and suitable therefor.

Section 2. There is hereby appropriated to the payment of the cost of making the improvements described in Sections 1 and 4 hereof (hereinafter referred to as "purposes"), the respective amounts of money hereinafter stated as the appropriation for said respective purposes. Said appropriation shall be met from the proceeds of the sale of the bonds authorized, and the State grant and the down payment

appropriated, by this ordinance. Said improvements shall be made as general improvements and no part of the cost thereof shall be assessed against property specially benefited.

Section 3. It is hereby determined and stated that the making of such improvements is not a current expense of said Borough.

Section 4. The several purposes hereby authorized for the financing of which said obligations are to be issued are set forth in the following "Schedule of Improvements, Purposes and Amounts" which schedule also shows (1) the amount of the appropriation and the estimated cost of each such purpose, and (2) the amount of each sum which is to be provided by the State grant hereinafter appropriated, and (3) the amount of each sum which is to be provided by the down payment hereinafter appropriated to finance such purposes, and (4) the estimated maximum amount of bonds and notes to be issued for each such purpose, and (5) the period of usefulness of each such purpose, according to its reasonable life, computed from the date of said bonds:

Section 6. The sum of \$79,000 received or to be received as a grant from the State of New Jersey Department of Community Affairs Local Recreation Grant Program is hereby appropriated to the payment of the cost of the ADA-restroom improvements at DiRenzo Park authorized in Section 4.8 hereof.

AN ORDINANCE AMENDING CHAPTER 217, "PARKS"; CHAPTER 228, RENTAL PROPERTY"; AND CHAPTER 169, "FOOD AND BEVERAGE VENDORS LICENSING", OF THE CODE OF THE BOROUGH OF NETCONG

**BE IT ORDAINED** by the Borough Council of the Borough of Netcong, in the County of Morris and State of New Jersey as follows:

**SECTION 1.** Chapter 217 of the Code of the Borough of Netcong, "Parks", Subsection 219-9 (H) and Section 219-10 shall be amended to read as follows:

#### § 217-9. Acts prohibited.

No person in any park or recreation area shall:

H. Allow any dog to run at large in the parks. Any dog found in any such park shall be deemed to be running at large unless the owner of the dog carries him or leads him by a strap or rope not exceeding six feet in length. All dogs are prohibited from entering any ballfield, sports court, playground area or other active recreational area, with the exception of trails and pathways that run through a park.

#### § 217-10. Hours of operation.

The Borough's parks shall be open daily to the public from 8:00 a.m. to sunset. No person other than Borough personnel conducting Borough business therein shall occupy or be present in the park during any hours in which the park is not open to the public. Any person who enters a park or is otherwise present in a park when such park is not open to the public shall be subject to the penalties set forth in this Chapter.

**SECTION 2.** Chapter 228 of the Code of the Borough of Netcong, "Rental Property", Subsection 228-3 (A) and Section 229-7 shall be amended to read as follows:

## $\S$ 228-3. Annual Registration required; terms.

A. Each rental unit shall be registered annually. The registration term shall commence on January 1 of each year and end on December 31. No rental unit shall hereafter be rented unless the rental unit is registered in accordance with this chapter.

#### § 228-7. Fees.

A. At the time of filing the rental registration form the owner or agent of the owner must pay a fee in the amount of \$35 per rental unit.

- B. The above fee includes the cost of one inspection. Additional inspections, whether due to a change of tenants, noncompliance, or inability to gain access for a scheduled reinspection, will require the payment of a fee of \$35 per reinspection visit. The cost for all inspections shall be paid in full no less than 24 hours prior to the scheduled reinspection.
- C. If any fee is not paid within 30 days of its due date, an additional late fee of \$25.00 per month for each month late shall be charged.

**SECTION 3.** Chapter 169 of the Code of the Borough of Netcong, "Food and Beverage Venders, Licensing", Section 169-8 "License Fees; Suspension or Revocation of License" shall be amended to read, in its entirety, as follows:

#### § 169-8. License fees; suspension or revocation of license.

- A. Each license shall be issued annually. The term shall commence on January 1 of each year and end on December 31. The annual fee shall be \$200 for each wagon, automobile or other vehicle of any kind in which the products are carried or from which they are sold. For each salesman, in addition to the above license fees, a fee of \$20 shall be imposed, except that a license for one salesman shall be issued without charge with the license for each wagon, automobile or vehicle of any kind in which such products are carried or sold.
- B. The license above provided for may be revoked by the Borough of Netcong for the violation of any of the provisions of this article, upon notice and hearing; provided, however, that a license may be suspended for a period not exceeding two weeks. Should any license be revoked, no part of the license fee shall be returned.
  - **SECTION 4.** This Ordinance may be renumbered for codification purposes.
- **SECTION 5.** All ordinances or parts of ordinances in conflict or inconsistent with any part of this Ordinance are hereby repealed to the extent that they are in such conflict or inconsistent.

**SECTION 6.** In the event that any section, part or provision of this Ordinance shall be held to be unenforceable or invalid by any court, such holding shall not affect the validity of this Ordinance as a whole, or any part thereof, other than the part so held unenforceable or invalid.

**SECTION 7.** This Ordinance shall take effect upon final passage and publication as required by law.

NOTICE IS HEREBY GIVEN, that the foregoing Ordinance was introduced in writing at a meeting of the Borough Council of the Borough of Netcong, County of Morris and State of New Jersey, held on the 8th day of May, 2025, introduced and read by title and passed on the first reading and that the said Governing Body will further consider the same for second reading and final passage thereon at a meeting to be held on the 12th day of June, 2025, at 7:30 p.m., prevailing time, at the Municipal Building in said Borough, at which time and place a public hearing will be held thereon by the Governing Body and all persons and citizens in interest shall have an opportunity to be heard concerning same.
