The DPW will be fixing the cement work that has been damaged as well as the lawns.

Mr. Anthony commented about the geese. There are abundant goose droppings at the park and a bunch of feathers in his yard. The mayor stated they are working on the goose problem.

Councilman Sylvester is concerned this is not totally encompassing as discussed. There was discussion among the Council and it was determined there is already no parking in the area of Koclas Dr. Councilman Laureys is concerned the wording is not as discussed. The attorney stated this was not possible. Councilman Sylvester stated in the end it will meet its intended purpose.

PRIVILEGE OF THE FLOOR TO THE COUNCIL

The Council president had nothing to report at this time.

Councilman Eddy reported that there are some serious flooding problems with the Family Ford property and McMullen St. He feels we need to move on this and possibly use eminent domain. Councilman Hathaway provided additional detail on the flooding in that area. This historically has been a problem. He continued commenting on this issue and noted the changes that have taken place over time. He agrees it is time to act on this problem. We need to do something for these residents. It was discussed among the Council that this property needs to be taken by the borough in order to correct and maintain this area. There was further discussion among the Council on this subject. The Council noted the situation has gotten worse since the circle project was completed and it continues to get worse. Mr. Blakeslee stated he has asked for a meeting with Family Ford but has had no response. He asked if the Council wants to have the attorney write

a letter to Family Ford due to their non-responsiveness. Councilman Nametko stated we need to find a way to keep the water from coming off of Rt. 80. There was discussion on hiring a professional to do a study to correct it and apply for a grant to pay for the repairs. There was additional discussion among the Council on possible solutions and causation for the flooding in this area. Councilman Hathaway stated we cannot continue to spend public funds on private property. Councilman Laureys asked that since this is private property is there any way the borough can maintain this area. The mayor stated Family Ford has filled in this area. There was continued discussion among the Council. He asked if we can have the private owners take care of these issues. Mr. Blakeslee stated we would be dealing with the state and they will not be prompt in solving the issue. Mr. Blakeslee will discuss this with the borough attorney to have him write a letter to Family Ford. Then he will work from there.

Councilman Hathaway wanted to discuss the annex of Roxbury Property for Arbolino Park expansion. He has discussed this with the Roxbury Mayor. He detailed what he would like to see happen. He would like to have Mr. Blakeslee set up a meeting with Roxbury so we can move forward with this annexation. Councilman Sylvester stated they already had a meeting with all parties involved. The mayor stated we should tell the borough attorney the borough will be moving forward with a meeting with Roxbury. The mayor stated we should have an agreement written, have both Mayors sign and move forward with the annexation. There was further discussion among the Council on this subject. Mr. Blakeslee will contact Mr. Bucco and the Roxbury Mayor.

Councilman Morton wanted to follow up on the Christmas tree situation; are there any ideas or plans for this? Councilman Hathaway stated the best idea presented was to have an artificial tree that could be erected in several parking spaces each year. It would be lasting. The mayor stated we may be able to get donations. Councilman Sylvester asked if there was space for a real tree. Councilman Morton is concerned about the timeframe. Councilman Hathway stated a cut tree could be purchased each year. Councilman Morton would prefer a real cut tree each year. There was brief discussion among the Council on this subject. Councilman Hathaway will do the research to determine the best way to move forward.

MAYORS COMMENTS

Mayor Still reported that he fired Mott MacDonald today. This company will not be doing any more engineering work in this town. French and Parello will be taking over. The mayor has stopped two projects: the DPW parking lot and the firehouse bathroom. There will be a redesign done on these projects so they are done correctly. Councilman Morton asked if they would be paving the entire parking lot.

PROCLAMATION

OVARIAN CANCER AWARENESS MONTH

WHEREAS, ovarian cancer is the fifth leading cause of cancer-related death among women in the United States, and the American Cancer Society estimates that in 2025 approximately 20,890 women will be diagnosed with ovarian cancer and 12,730 will die from the disease nationwide—including an estimated 670 new cases and 340 deaths in New Jersey; and

WHEREAS, a woman's lifetime risk of being diagnosed with ovarian cancer is approximately 1 in 91, and her lifetime risk of dying from the disease is approximately 1 in 143; and

WHEREAS, due to vague, nonspecific symptoms and the absence of a reliable early detection test, the majority of women are diagnosed at Stage III or later, when the cancer has already spread beyond the ovaries; and

WHEREAS, although the five-year survival rate for Stage I ovarian cancer exceeds 90 percent, only 15 percent of cases are diagnosed at this early stage. For those diagnosed in later stages, the five-year survival rate drops below 30 percent; and

WHEREAS, while screening tools such as mammograms and Pap tests exist for breast and cervical cancers, no equivalent screening test exists for ovarian cancer, making awareness of symptoms and risk factors essential for early intervention; and

WHEREAS, increased public education about ovarian cancer can help save lives by promoting earlier diagnosis, supporting access to gynecologic oncology care, and encouraging research funding for better detection and treatment options; and

WHEREAS, during the month of September, the Borough of Netcong joins survivors, families, healthcare professionals, advocacy organizations, and all those committed to raising awareness, remembering lives lost, and offering hope for a future with better outcomes and ultimately, a cure.

NOW, THEREFORE, I, Mayor Still, do hereby proclaim September 2025 as OVARIAN CANCER AWARENESS MONTH in the Borough of Netcong, New Jersey, and encourage all residents to participate in awareness activities, wear teal in support, and engage in conversations that help save lives and support the thousands of families affected by this devastating disease.

WHEREAS, the Borough Council of the Borough of Netcong awarded a contract to D.L.S. Contracting, Inc. for the Jenny Lind Street Resurfacing and Sidewalk Improvement Project in the amount of \$303,053.00 on September 12, 2024; and

WHEREAS, the Jenny Lind Street Resurfacing and Sidewalk Improvement Project in was performed and completed by D.L.S. Contracting, Inc. in June of 2025;

WHEREAS, the as-built amount completed and billed by D.L.S. Contracting, Inc. is \$239,894.75 a decrease of \$63,158.25 from the contract amount of \$303,053.00;

WHEREAS, the decrease is based on as-built field measurements and quantities for the completed project.

WHEREAS, the NJDOT Local Transportation Grant Program grant for the project is \$250,000.00 and therefore, all construction costs are covered by the grant.
