MINUTES OF THE MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF NETCONG HELD SEPTEMBER 11, 2025 AT THE NETCONG MUNICIPAL BUILDING, 23 MAPLE AVENUE, NETCONG, NEW JERSEY COMMENCING AT 7:30 PM.

The meeting was called to order by Mayor Still at 7:30 PM. He read the following:

Twenty-four years ago today, our lives were changed forever by a horrific act of violence to the American people. Today we remember those we lost and those who gave everything. Last night Charlie Kirk was assassinated for doing what he loved, inviting students to challenge his political and cultural views. His family lost a son, a husband, and a father. Political violence has no place in our society; however, we are seeing it more often than we should. Our hearts are broken, and lives have been shattered. It's time to bring back the America that we all knew and loved, a caring and compassionate society, one who treated each other with respect and dignity. Let's have a moment of silence for Charlie and the victims of 911.

PUBLIC PORTION OF MEETING

Mrs. Bernadette Dalesandro, 30 Barone St., asked about the work to be done on Railroad Ave. Mr. Blakeslee explained this is a drainage problem that needs to be fixed. The mayor stated we are just moving a drain. Mrs. Dalesandro is concerned about the increase of the solid waste. The Council explained the reason for the increase. She would like to know what the amendment is to the Rock-Solid agreement. Mr. Blakeslee stated it is just a name change for the LLC. There are no changes to the details in the agreement. Mrs. Dalesandro also requested an update on the Barone St. project. Mr. Blakeslee stated there are no updates at this time.

Mrs. Michele Franchi Ruocco, 39 Main St., wanted to know what is the official date to put out political signs. The mayor explained there is no timeline for this. Councilman Hathaway gave further info on this. Councilman Sylvester stated his read is 6 weeks for state property. There was further discussion on this issue. Councilman Hathaway stated there is a maintenance schedule for state properties so the signs could be removed at any time. They can be put on private property at any time. She would also like the Council to know Carmines will be hosting a time each Sunday from next Sunday up to election day from 12-2 for the candidates to be there for the public to come meet them and ask questions. (Meet the candidates) She also thought it would be nice to honor seniors in our town (proclamation etc.) Councilman Nametko stated we have honored senior milestones with resolutions and proclamations in the past.

CORRESPONDENCE

Letter – Musconetcong Sewerage Authority – PFAS

The mayor commented on this letter. This issue is going to cost the borough a lot of money. Mr. Blakeslee stated we will be getting some money from these companies from a class action suit. Councilman Sylvester stated 3M is giving the towns peanuts on the dollar to remove PFAS from our systems and will then continue to produce products that produce PFAS. Councilman Hathaway had commented on this issue. His concern is they will continue to make these chemicals. Councilman Sylvester stated towns have now lost their rights to sue. There was discussion among the Council on the high cost of removing these chemicals from our water sources and what will be done with it once it is removed. Lengthy discussion on this problem continued among the Council. Councilman Sylvester stated this is a call to arms to write a letter to ask for a 120-day comment period. The mayor stated this is being run by DEP and asked how do you fight

DEP? Councilman Sylvester asked Mr. Blakeslee to have a letter written. Mr. Blakeslee will contact the borough attorney for assistance with the letter.

BOROUGH ADMINISTRATOR REPORT

Mr. Blakeslee provided a few comments on his report. He would like to have the CFO and Auditor attend the next agenda meeting to explain the bond sale process vs. a note sale. He described the situation and the need for an official statement. Councilman Nametko provided additional explanation about this.

Solid Waste Utility:

The Borough collected \$23,127.81 in 2025 compared to \$16,540.46 in 2024.

Total Current Fund Year to Date:

The total Current Fund Income Year to date for 2025 is \$10,128,936.38 as opposed to \$9,325,393.98 in 2024.

Total Water and Sewer Utility to Date:

The total Water and Sewer Utility Income Year to date for 2025 is \$926,555.83 as opposed to \$907,286.67 collected in 2024.

Total Solid Waste Utility to Date:

The Solid Waste Utility Income Year to date for 2025 is \$233,401.00 as opposed to \$192,751.37 collected in 2024.

Councilman Nametko was recently made the chair of the Morris County solid waste committee. He provided details regarding the county hauling. There will be an increase over the next 5 years. He also discussed the solid waste and recycling process and the changes. Our health insurance will be going up 35% for 2026. Mr. Blakeslee stated the borough is hoping the state will allow this to be outside the 2% cap. The mayor asked if we are looking for other options. Mr. Blakeslee detailed what he and the CFO have been looking into to make a change. The problem that the borough has is that the late notification of this change will not allow us to change for 2026. The Council will see a resolution to increase the solid waste billing amounts to help offset the increases.

RESOLUTION TO INCREASE ANNUAL SOLID WASTE RATES

WHEREAS, The Borough of Netcong Solid Waste Utility according to the Netcong Borough Code, Chapter 80, section 5 allows for the Borough to review and adjust rates annually based upon the annual budget of the Solid Waste Utility; and

WHEREAS, the Finance Committee has reviewed the 2025 budget and projections for the 2026 Solid Waste Utility Budget; and

WHEREAS, the Borough contract with Mount Olive for trash pickup and the contract with the Morris County Municipal Utility Authority have increased for 2026 for their respective services; and

WHEREAS, the increases of the garbage and recycling hauling have caused a need to increase the rates of the Solid Waste Utility for 2026 in an amount of 6% from the current rate of \$300 per user to \$318.00 per user;

WHEREAS, as required pursuant to Resolution No. 24-06 of the Netcong Borough Planning Board, the Redeveloper is required to post certain performance and maintenance guarantees with the Borough; and

WHEREAS, appended hereto as Exhibit A is an amendment to the Redevelopment Agreement that permits the Redeveloper designated and reflected on the Redevelopment Agreement to be amended to RSB Netcong, LLC, and further amends the Redevelopment Agreement to include the posting of required performance and maintenance guarantees.

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 268, VEHICLES AND TRAFFIC, ARTICLE VIII SCHEDULES, OF THE CODE OF THE BOROUGH OF NETCONG, COUNTY OF MORRIS, STATE OF NEW JERSEY TO AMEND THE PARKING RESTRICTIONS ON KOCLAS DRIVE AND DELL AVENUE

BE IT ORDAINED, by the Borough Council of the Borough of Netcong, in the County of Morris, and State of New Jersey, as follows:

Section 1. Chapter 268, Vehicles and Traffic, Article VIII Schedules, Section 268-18, Schedule 1 – No Parking, is hereby amended and supplemented by amending the parking restrictions on Koclas Drive and Dell Avenue by deleting the existing restrictions and replacing them with the following:

Name of Street	Side	Location
Koclas Drive	East and North	From the northerly side of Allen Street to the intersection with Lake Street.
Dell Avenue	North	Between the intersection of Dell Avenue and Lake Street and the intersection of Dell Avenue and Allen Street

Section 2. This Ordinance may be renumbered for codification purposes.

- **Section 3.** All Ordinances of the Borough of Netcong which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.
- **Section 4.** If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.
- Section 5. This Ordinance shall take effect immediately upon final passage, approval, publication and the posting of the appropriate signs as required by law.
