**A RESOLUTION CONSENTING TO A TREATMENT WORKS APPROVAL
APPLICATION TO PROVIDE SEWER SERVICE FOR MOUNTAIN VIEW AT
NETCONG, BLOCK 26, LOTS 6 AND 10 IN THE BOROUGH OF NETCONG, COUNTY
OF MORRIS AND STATE OF NEW JERSEY**

WHEREAS, Mountain View at Netcong Urban renewal, LLC (“Developer”) is the owner of Block 26, Lots 6 and 10 located in the Borough of Netcong, Morris County, New Jersey (“Property”); and

WHEREAS, on July 22, 2024 the Developer received preliminary and final site-plan approval from the Netcong Borough Planning Board; and

WHEREAS, the Developer has requested that the Borough approve of the Developer’s Treatment Works Approval Permit Application (TWA); and

WHEREAS, the Borough’s Conflict Engineer has reviewed the TWA application prepared by the Developer and in a letter dated November 17, 2025 finds same to be in proper form and take no engineering objection; and

WHEREAS, the Borough, in accordance with the State's sanitary sewer system rules and regulations, must consent to the TWA application prior to the Developer submitting said application to the N.J.D.E.P.; and

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Netcong, in the County of Morris, and State of New Jersey, that the Borough hereby consents to the Developer filing an application with the N.J.D.E.P. for the TWA required in order to connect the Property to the sanitary sewer system. The mayor is hereby authorized and directed to execute the permit application on behalf of the Borough provided the above-noted conditions are met.

This Resolution shall take effect immediately.


